#### Virtual Meetings

#### Meetings for Worship; Meetings for Worship with Attention to Business; and Weekly Forums:

Chapel Hill Friends Meeting has been using Zoom software as an online platform to hold Meetings for Worship; including meetings with attention to business, forums, social hours, and committee meetings. Friends are doing our best to sustain spiritual connections and support the life of the Meeting during the pandemic.

Ministry and Worship and the Zoom ad-hoc committee ([zoom@chapelhillfriends.org](mailto:zoom@chapelhillfriends.org)) wish to make this experience as rich as possible. Even apart, we wish to come together in the Light. To aid this, we advise those attending of the following:

- On entering the Meeting for Worship via Zoom, everyone's microphone will be muted (you do not need to mute yourself on entry). We suggest remaining muted when not speaking to avoid background noise.
- If led to share vocal ministry, the "Unmute" button on the bottom left of the Zoom screen is pressed. When finished speaking, the "Mute" button may be pressed in the same location.
- We recognize you may need to move around and settle. If doing so Friends are asked to use the "Stop Video" option (bottom of screen next to Mute) – your name or profile picture will display until pressing "Start Video" again. This will minimize visual distraction for others,
- There is an option on the upper right of your Zoom screen to select "Speaker View" for a large window for the current speaker or "Gallery View" that shows small windows for all participants.

The Ministry & Worship Committee reminds Friends that our traditional Quaker practice in Meeting for Worship, in-person or online, is to refrain from sharing vocal ministry more than once in the hour to give

others space for messages. Though it may be more challenging online, we strive to listen deeply in the silence and be open to the leadings of the Spirit that may move us to speak.

### **Quaker House in the News.**

Quaker House has continued its work throughout the current Covid-19 crisis. GI Rights Hotline Counseling and the Domestic Violence, Sexual Assault, and Moral Injury Counseling Programs continue using virtual communication.

*From our GI Rights Hotline Counselors:*

"We received this email last week from the mother of a soldier who went AWOL from basic training.... We're glad he found the GI Rights Hotline and reached out to us."

*"Dear Steve and Lenore and GI Hotline,  
We want to say "thank you" for all the help received while our son was having trouble in the Army. Through your help and counsel we were able to get him answers and back on track. The process was much easier to deal with after having called and talked to you both on many occasions. He has now been discharged and that process was unexpectedly a breeze. You both knew what, where, when and how to expedite the process and it made the discharge much easier. Our son says, He is very thankful for the HOPE that you all gave to him. We as a family are eternally grateful for your knowledge and help."*

Domestic Violence, PTSD and Moral Injury Counselor Joanna maintains a busy schedule of sessions with clients, all of them now by telephone using a HIPAA compliant app. One client, referred by a mental health counselor on Ft. Bragg, is a 38- year- old male that just medically retired from the Army. He is experiencing severe PTSD and moral injury from multiple deployments in Afghanistan. Many civilian and military workers are being called back to Ft. Bragg, resulting in increased anxiety. Joanna is pleased that military counseling staff is referring clients to us. Joanna continues to counsel families experiencing domestic strife.

Executive Director Kindra Bradley and GI Rights counselor Steve Woolford organized an online workshop for the GI Rights Network, with Deborah Karpatkin, a lawyer who does significant work with conscientious discharge cases. Kindra continues to Co-Chair the board, Steve continues as Treasurer, and Lenore continues on the Council. They have increased the Cases Collaborations Network calls to twice a month via the Quaker House Zoom account in order to keep pace with the changing COVID picture as it affects the different branches of the military.

In other work, Kindra has maintained collaboration with active peace groups, including Veterans for Peace and About Face/Veterans Against the War. Kindra will be giving a workshop at the annual gathering of Palmetto Friends, and has conducted online forums at First Friends and New Garden meetings. Many of the annual sessions of Quaker organizations have been cancelled or will take place remotely. This will save Quaker House some travel expense, but will limit our ability to reach out to Friends personally.

Kindra has also been active in listening sessions, and attended (online) the public release event of the report of the National Commission on Military, National, and Public Service. She has studied portions of the recommendations relevant to Quaker House's mission. This is reflected in an upcoming newsletter article and will be part of future conscientious objection education forums, workshops, and materials. Selective service will remain active, will probably include women, and will focus on recruiting in schools.

This winter, the heating/AC system in Quaker House had to be replaced. We were able to cover this expense from the building reserve fund. The house is in good condition, including a recently replaced roof. Support for Quaker House by donors and meetings has remained strong, but many people are experiencing financial stress. Some meetings that support Quaker House are reporting decreased contributions. We continue to monitor this potential impact on our funding. Quaker House applied for a PPP loan and received a grant to cover staff paychecks and utilities bills for eight weeks. This funding will be significant in allowing us to meet our budget during a time of economic stress on our donors.

Fayetteville Friends meets at Quaker House –

Ann Ashford has been a member of Fayetteville Friends for decades. Her husband John has always been a friend to the meeting, has attended worship with us, and often participated in activities, work, and gatherings. Both Ann and John have been stalwart advocates for peace, justice, community, and the mission of Quaker House. On March 29, John required surgery to repair a broken hip from a fall. Soon afterwards, he developed illness from COVID-19. On Mother's Day, May 10, John passed away. His physical presence and loving nature will be greatly missed. ## What Can I Do To Help The IFC?

Thank you to the many Friends who attended the informative and comprehensive forum on May 24<sup>th</sup>, featuring Jackie Jenks, Director of Interfaith Council for Social Services. Jackie shared that IFC programs are ongoing during the coronavirus pandemic, and the IFC staff and volunteers are making the necessary changes to promote safety and health. To-go meals are provided at Rosemary Street (100 West Rosemary) instead of sit-down lunches and dinners at the Community Kitchen. Pantry clients call in grocery orders, which are filled by staff and volunteers, and distributed in the Rosemary Street parking lot. Interviews for Emergency Financial Services are conducted by telephone and not face-to-face. Single residents of Community House and Homestart are being temporarily housed in a nearby hotel, with housing funds provided from county and town resources. IFC provides women and men in the hotel with meals and laundry services. Families remain at Homestart, as this facility offers a more beneficial home for children. The Rosemary Street facility is available to community members on specified hours for computer and cell phone use.

Here's how you can help:

1. **Donate food items for the Pantry.** A list of the most needed items are posted on the [IFC website](#). Contributions are accepted M-F, 9:00 am to 4:00 pm at Rosemary Street. Call ahead (919 929 6380) to arrange to be met in the parking lot, or leave contributions in bags by the basement door. There's a telephone by the basement door for your use to call staff/volunteers and let them know donations are ready for pick up. If all are busy and no one answers, leave the bags.
2. **Donate masks.** The IFC is providing masks for all clients, staff and volunteers. Call 919 929 6380 to let staff/volunteers know that you have masks to donate. The hours are the same as for food donations — 9:00 am until 4:00 pm M-F.
3. **Donate money.** Traditional food sources — restaurants, UNC Dining services, congregations and food drives, many grocery stores — are not available for donations due to the pandemic. The IFC must buy more food and well as provide for clients in other ways, and client needs are likely to increase as stimulus checks and rent forgiveness programs end. Please consider a financial contribution to the IFC.

1. Opening worship and query. Query: What are we doing to welcome newcomers to Meeting for Worship, to listen sensitively to their needs and hesitations, and to encourage their continued attendance?

Due to technical problems with Zoom, some participants were not able to log on with audio and/or video working. The Clerk had to ask everyone to leave the meeting and rejoin. This took time away from our usual opening and caused some reports to be postponed.

2. The Minutes of the April Meeting for Worship with Attention to Business (MWAB) were approved.

3. A letter for the transfer of membership for Ann Riggs from Chapel Hill Friends Meeting (CHFM) to Annapolis Friends Meeting was presented and approved. (See appendix 1.)

4. Lynn Drake presented an announcement for the Shotts Memorial/Leadership Development Fund regarding the Friends General Conference (FGC) Virtual Gathering 2020.

Friends General Conference invites your participation in a Virtual Gathering, June 26-July 4. This is a unique opportunity to experience the annual Gathering of Friends from the comfort of your own home. No traveling is required!

The Shotts Memorial/Leadership Development Fund Committee is offering financial support to Chapel Hill Friends Meeting participants who want to take advantage of this opportunity. 5. Dottie Heninger and Gwynne Pomeroy, Co-clerks of Nominations Committee, presented the annual report and the list of givers of time and service. The list will be presented for final approval next month. (See appendix 2.)

6. The Publications & Communications (P&C) annual report was postponed.

7. Maura Murphy, Treasurer, presented a draft budget for the next fiscal year as well as the third quarter report. The pandemic has affected both expenditures and contributions, but over all we are doing well. However, significant benevolence expenditures are yet to come. The pandemic is expected to decrease contributions and parking space rental in the coming year. Substantial cuts to the budget were made accordingly. We will give final approval of the proposed budget next month. (Appendix 3.)

8. Tom Munk, Co-clerk of Peace & Justice (P&J) Committee, presented the annual report. (See appendix 4.)

9. Transition & Support Committee annual report was postponed.

10. The revised response to FGC through Piedmont Friends Yearly Meeting (PFYM) about the anti-racism efforts of Chapel Hill Friends Meeting (CHFM) report was postponed.

11. The InterFaith Council Committee annual report was postponed.

12. Dave Curtin, Clerk of the Library Committee, presented the revised proposal for an ad hoc Pre-Design Renovation Committee to consider renovation goals for the entry area and library of the Meeting house. Because of the COVID-19 pandemic, we would like the committee to meet via Zoom (or other means not requiring face to face meeting) and not enter the Meeting building. We have been talking to the Hospitality Committee and Building & Grounds (B&G) and believe members should come from Library, Hospitality, Ministry & Worship, Finance, B&G, and any other committee that wishes to contribute. After some discussion, this proposal was approved. John Hite, Meeting resident, offered to use his laptop camera to help view the space if needed.

13. PFYM is planning a virtual annual session, probably in late July. Stay tuned.

14. Will King's presentation of his letter requesting support from the Meeting as a Conscientious Objector will again be postponed.

15. Next MWAB will be 9:00 am June 21, 2020.

## Appendix 4

Peace and Justice Committee Annual Report 2020

May, 2020

Since our last report, in March of 2019, the Peace & Justice Committee has been busy. We conduct open meetings each month at the rise of late Meeting on second Sundays. We conduct informative, and at times spirited discussions of the many peace and justice activities of the Meeting and of individual Friends. This report highlights only some of these activities, which are too numerous to report in full.

**Benevolences:** This year, the Meeting approved a revision to the way that we apportion benevolences. The revision was generated with extensive input from many Friends. The Meeting for Worship with Attention to Business will take direct responsibility for oversight of our five largest, legacy benevolences. These benevolences will receive 79% of the amount reserved for Peace and Justice Benevolences. The remaining 21% were discerned (and will be discerned annually) by the Peace and Justice Committee. P&J will continue to meet the following guidelines for their benevolence decisions as stated in previous P&J reports: "Meeting benevolences MUST be either (a) Quaker-affiliated organizations, or (b) local organizations that reflect our Meeting's values and with which members of the Meeting are closely involved."

**Bahamas.** Tim Fogarty, for the P&J committee, facilitated a donation by the Meeting to support individuals devastated by Hurricane Dorian.

**FCNCL.** The committee joyfully supported the creation this year of the Friends Committee on North Carolina Legislation under the care of Piedmont Friends Yearly Meeting. FCNCL will focus its efforts this year on electoral reform, access to quality healthcare, environmental protection (includes climate change), and criminal justice reform. We are grateful to Karen Porter for her leadership.

**Solar Panels.** The Meeting for Worship with Attention to Business has approved a committee proposal to set up a cross-committee investigation of the possibility of installing solar panels on the Meetinghouse and the Schoolhouse. We are grateful for the leadership of Hank Elkins and Wendy Michener.

**Advocacy Teams.** Curt Torell and Tom Munk have created and led an FCNL Advocacy Team this year that has met multiple times with our Congressman, David Price, his staffers, and staffers for Senators Burr and Tillis. We are working on creating relationships with those staffers, recognizing that human connection is an excellent way to create positive change. This year Congress has passed several bills limiting the war-making powers of the President. Our work continues. Please let Curt or Tom know if you would like to join us.

**Anti-racism.** We have been holding in the Light ways to establish ourselves as an anti-racist meeting and that we continue to do this work as PFF/YM also look to work on this through their meetings.

We are particularly grateful for the services of Karen Porter, who clerked the committee for the first half of the year. With the joyful birth of her grandson, she has retired from the committee.
