# **Virtual Meetings**

## Meetings for Worship; Meetings for Worship with Attention to Business; and Weekly Forums:

Chapel Hill Friends Meeting has been using Zoom software as an online platform to hold Meetings for Worship; including meetings with attention to business, forums, social hours, and committee meetings. Friends are doing our best to sustain spiritual connections and support the life of the Meeting during the pandemic.

Ministry and Worship and the Zoom ad-hoc committee (<u>zoom@chapelhillfriends.org</u>) wish to make this experience as rich as possible. Even apart, we wish to come together in the Light. To aid this, we advise those attending of the following:

- · On entering the Meeting for Worship via Zoom, everyone's microphone will be muted (you do not need to mute yourself on entry). We suggest remaining muted when not speaking to avoid background noise.
- · If led to share vocal ministry, the "Unmute" button on the bottom left of the Zoom screen is pressed. When finished speaking, the "Mute" button may be pressed in the same location.
- · We recognize you may need to move around and settle. If doing so Friends are asked to use the "Stop Video" option (bottom of screen next to Mute) your name or profile picture will display until pressing "Start Video" again. This will minimize visual distraction for others,
- · There is an option on the upper right of your Zoom screen to select "Speaker View" for a large window for the current speaker or "Gallery View" that shows small windows for all participants.

The Ministry & Worship Committee reminds Friends that our traditional Quaker practice in Meeting for Worship, in-person or online, is to refrain from sharing vocal ministry more than once in the hour to give others space for messages. Though it may be more challenging online, we strive to listen deeply in the silence and be open to the leadings of the Spirit that may move us to speak.

# Food Delivery to IFC While Meetinghouse is Closed

The meeting's IFC committee has devised a plan to make Friends' donations of food items to the IfC more convenient. You can find a <u>list of recommended food items</u> on the IFC website (and you can purchase food online).

- 1. Please bring food items to the meetinghouse porch on first and third Wednesdays of each month. Canned goods are to be placed in cardboard boxes labeled "IFC." Place bags of food in the plastic bin with a secure top. Members of the IFC committee will pick up the donations at 3:00 pm on first and third Wednesdays and deliver them to the Rosemary parking lot. This system will eliminate the need for individual Friends to drive to Rosemary street with food contributions, though you are still welcome to do that. The first day of food delivery to IFC from our meetinghouse porch will be Wednesday, June 17th.
- 2. Please do not leave food on the meetinghouse porch on days other than the designated delivery days first and third Wednesdays. Bring your food donations prior to pick-up time of 3:00 pm.
- 3. From the IFC website, requested food contributions include pasta, spaghetti or pasta sauce, canned tuna or other meats, macaroni and cheese mixes, canned fruit, oatmeal, baking mixes (cornbread, muffins) and crackers (saltines and others). ### What You Can Do For A Fair Election

Pam Schwingl shares with Friends:

We have two weeks to the election, thus your letters and emails and calls are important now. Please go to the <u>FCNCL.org</u> website for <u>Action Alerts</u> and <u>Fact Sheets</u> on election integrity.

Please consider writing a letter to:

- The editor of your local paper
- State Board of Elections (elections.sboe@ncsbe.gov)
- County Board of Elections (Orange County: <u>vote@orangecountync.gov</u>; Chatham County: <u>elections@chathamnc.org</u>; Durham County: <u>elections@dconc.gov</u>; Person County: <u>personboe@personcountync.gov</u>)
- Your state representatives and senators

Urge them to respect the need to count every vote and defend the integrity of our election.

The ability of the Board of Elections to count late votes in NC could still go to the supreme court even after the 4th U.S. Court of Appeals voted 12-3 to extend the time limit for receiving ballots. This could put late mail in ballots in jeopardy. Time is of the essence.

## **Encourage All Citizens To Register And Vote**

The Peace and Justice Committee urges all citizens to register and vote.

It is possible to register and vote the same day at early voting sites.

Early voting (and same-day voter registration) starts this Thursday 10/15/20 and ends Saturday 10/31/2020.

During early voting, voters may cast a ballot at any early voting site in their county. This is different from Election Day when registered voters must vote at their assigned precinct.

To register to vote same-day, the voter must prove their residence by showing any of the following documents with their current name and address:

- North Carolina driver's license
- Other photo identification issued by a government agency. Any government-issued photo ID is acceptable, provided that the card includes the voter's current name and address.
- A copy of a current utility bill, bank statement, government check, paycheck, or other government document showing the voter's name and address.
- A current college/university photo identification card paired with proof of campus habitation.

Query: What am I doing to reduce polarization within our community and the larger community?

- 2. Welcome and review of the agenda.
- 3. The minutes of the September 20, 2020 Meeting for Worship with Attention to Business (MWAB) were approved as written.
- 4. Maura Murphy, Treasurer, presented the first quarter financial report for July-September 2020. Our income is in line with what we usually have at this time. Committee expenses are less than usual. Under utilities, the cost for water shows a negative number because we share the cost with Chapel Hill Early School and will get reimbursement later. We are ahead for the year. A question was raised about the possibility of paying the credit card fee when making a donation online. The bank will get their fee regardless so it is of minimal help to the meeting. Another question arose about setting up auto-pay for monthly donations from one's bank account. This would require having the BB&T account number but does save credit card fees. Will benevolences go up because our expenses are low? We are open to that possibility but can't decide now. (Appendix 1.) The report was accepted with thanks.
- 5. Dave Curtin, Clerk of Library Committee, presented the Library Committee Annual Report. One addition is the book donations made to Orange Correctional Center. We are up to date on taking minutes to the Guilford College Archives. (Appendix 2.) The report was accepted with gratitude.

- 6. Jeff Brown, Clerk of the Ministry and Worship Committee, reported on the Clerk's Retreat September 26, 2020. Twenty-five people attended this online gathering. (Appendix 3.) Friends from the Carolina Friends School Board and the co-clerk of the Piedmont Friends Yearly Meeting (PFYM) attended. As a result, PFYM will offer a clerk's workshop to PFYM that Chris Stanley is helping present. The report was accepted with thanks.
- 7. Naveed Moeed, Co-clerk of the Peace & Justice Committee (P&J), presented a minute in support of the nonviolent efforts reflected at https://choosedemocracy.us. George Lakey, experienced trainer in strategic nonviolent direct action, has led this initiative. P&J requests that the Meeting approve the minute:

American democracy is in peril. For the first time in our history, we have a President refusing to commit to a peaceful transfer of power should he lose the election. This is the time, not to agonize, but to organize. Some Friends have begun non-violent efforts that are reflected on <a href="https://choosedemocracy.us">https://choosedemocracy.us</a>. We support those efforts and invite Friends, as they are moved, to visit this website, take the pledge thereon proposed and attend some of the training sessions listed there.

We pray we will not need to prepare. But if we fail to plan, we plan to fail.

The minute was approved with gratitude.

- 8. Hank Elkins, Clerk of the Rooftop Solar Subcommittee along with committee members, presented the responses to questions that have been submitted about the proposal and a brief update on the work of this subcommittee. To proceed, we need to pay a down payment of \$6850. We can then apply for a rebate through Duke Energy in early January 2021 (only available 2021-2022) which means the remainder we need to raise is \$39,000. The panels will pay for themselves in ten years. We pay for energy anyway. If we install solar panels, we will pay upfront for ten years of energy and then receive energy cost-free after that. We will be saving \$35,000 that we would be spending anyway. A long discussion ensued. To be continued next month.
- 9. A. Hart Pillow, Clerk of Quaker Earthcare Witness, reported that QEW met October 10, 2020 and came to unity in support of this project.
- b. Bob Durovich, Co-clerk of the Buildings & Grounds Committee, reported there were no show stoppers regarding the project. Many questions were raised by individuals on the committee and some unease. But many were green lights.
- c. Naveed Moeed, Co-clerk of P&J, presented their report. Installation of rooftop solar panels may be a drop in the ocean of the climate change crisis but so doing does send a message. P&J recommends pursuing the rooftop solar project.

d. Finance Committee will report in November.
10. The next MWAB will be 9 am, Sunday, Nov. 15, 2020.







## Library Committee Annual Report (2019-2020)

The Library Committee maintains and improves the Meeting's collection of library books, periodicals, pamphlets, and other resources to further the life of the Meeting and its participants. It annually reviews the collection and purchases new materials on its own initiative as well as considering requests from committees and individuals. It works particularly closely with the Ministry and Worship Committee, the Children's and Youth Religious Education Committee, and the Adult Religious Education Committee. Attendance at committee meetings is open to all.

This has been a difficult year with the Meeting house closing in March. We have added some new members and met several times up till then. We were working through book donations and other new projects.

## Highlights from the last year.

- 1. The library committee has continued to maintain the collection in Library Thing, our online guide accessible through the link on our web site, and we are working on ways to enter pamphlets and other publications that are not from Pendle Hill.
- We did not purchase any new books, but have added several donated books.
- We gave 20+ books to the Eno Friends Meeting in Hillsborough.
- We were trying to work through all the donated books, and offer some to the meeting. Unfortunately, the meeting house closed just as we set up one of the first offerings.
- We were contacted by the new chaplain at the Orange Correctional Center and provided a box of Quaker books, including several Faith and Practice copies at his request.
- We met with Hospitality and Building and Grounds Committees to talk about possible remodeling/updates to the Library, and are going to set up a ad-hoc committee to look at updates to the Library, foyer, and front of the meeting. Several people have volunteered to join it, but some have dropped off, probably because it is not possible to be in the space to plan.
- We also discussed setting up a web page with links for the meeting to use remotely, but that will need much more work.
- We provided the archivist at Guilford with copies of our newsletter and Meeting for Worship with Attention to Business minutes.

1. Find a safe way for people to once again get into the Library and check out books, pamphlets, CDs, and videos/DVDs.

Clerks' Retreat

September 26, 2020, 10:00 AM

Summary

The annual Clerks' Retreat is convened by the Ministry & Worship Committee as an opportunity for committee clerks and other members and attenders to review and clarify expectations, roles, responsibilities, and Quaker process. This year, in the midst of a pandemic, 25 Friends gathered online on a Saturday morning.

After opening worship, Clerk of the Meeting, Chris Stanley, led a discussion of the basic logistics of committee clerking and Quaker process. In brief, clerks are servants, organizers, and communicators. Discussion touched on agendas, minutes, and committee calendars, and more importantly worshipful spirit-led meetings, care for personal relationships, building community, and communication between committees. Clerking skills include careful listening to each committee member, finding unity, using silent worship to reset a discussion, framing in terms of the Meeting community, and shepherding time and task orientation in worshipful ways.

Friends discussed a committee's role in Quaker process of discernment. A committee threshes concerns, problems and solutions; sits with leadings; and strives to reach unity on minutes. A committee is responsible for making a recommendation to Meeting for Worship with Attention to Business and being ready to explain its process and leadings and how the committee reached unity. Friends were reminded that a committee is authorized by the Meeting to do certain tasks and is expected to get approval from the Meeting to seek information from other organizations or to represent the Meeting outside of the Meeting community. Also, Committee clerks are expected to take the lead on work that relies on cross-committee communication.

Friends discussed challenges of being limited to online committee meetings during the pandemic. A combination of the Meeting's Zoom Pro account and personal accounts of committee clerks have met the need for online meetings so far. The Zoom working group offered assistance to committees in setting up meetings via the Meeting's account.
