Virtual Meetings

Meetings for Worship; Meetings for Worship with Attention to Business; and Weekly Forums:

Chapel Hill Friends Meeting has been using Zoom software as an online platform to hold Meetings for Worship; including meetings with attention to business, forums, social hours, and committee meetings. Friends are doing our best to sustain spiritual connections and support the life of the Meeting during the pandemic.

Ministry and Worship and the Zoom ad-hoc committee (zoom@chapelhillfriends.org) wish to make this experience as rich as possible. Even apart, we wish to come together in the Light. To aid this, we advise those attending of the following:

- On entering the Meeting for Worship via Zoom, everyone's microphone will be muted (you do not need to mute yourself on entry). We suggest remaining muted when not speaking to avoid background noise.
- If led to share vocal ministry, the "Unmute" button on the bottom left of the Zoom screen is pressed. When finished speaking, the "Mute" button may be pressed in the same location.
- We recognize you may need to move around and settle. If doing so Friends are asked to use the "Stop Video" option (bottom of screen next to Mute) – your name or profile picture will display until pressing "Start Video" again. This will minimize visual distraction for others,
- There is an option on the upper right of your Zoom screen to select "Speaker View" for a large window for the current speaker or "Gallery View" that shows small windows for all participants.

The Ministry & Worship Committee reminds Friends that our traditional Quaker practice in Meeting for Worship, in-person or online, is to refrain from sharing vocal ministry more than once in the hour to give others space for messages. Though it may be more challenging online, we strive to listen deeply in the silence and be open to the leadings of the Spirit that may move us to speak.

Food Delivery to IFC While Meetinghouse is Closed

The meeting's IFC committee has devised a plan to make Friends' donations of food items to the IFC more convenient. You can find a [list of recommended food items](#) on the IFC website (and you can purchase food online).

1. Please bring food items to the meetinghouse porch on first and third Wednesdays of each month. Canned goods are to be placed in cardboard boxes labeled "IFC." Place bags of food in the plastic bin with a secure top. Members of the IFC committee will pick up the donations at 3:00 pm on first and third Wednesdays and deliver them to the Rosemary parking lot. This system will eliminate the need for individual Friends to drive to Rosemary street with food contributions, though you are still welcome to do that. The first day of food delivery to IFC from our meetinghouse porch will be Wednesday, June 17th.
2. Please do not leave food on the meetinghouse porch on days other than the designated delivery days - first and third Wednesdays. Bring your food donations prior to pick-up time of 3:00 pm.
3. From the IFC website, requested food contributions include pasta, spaghetti or pasta sauce, canned tuna or other meats, macaroni and cheese mixes, canned fruit, oatmeal, baking mixes (cornbread, muffins) and crackers (saltines and others). 1. Opening worship and Query: *How do we help each other face conflicts with patience, forbearance and openness to healing?*
2. Welcome and review of agenda. No first time attenders.
3. The minutes from the December 20, 2020 Meeting for Worship with Attention to Business (MWAB) were approved as written.
4. John Bell, Chapel Hill Friends Meeting (CHFM) representative to the Carolina Friends School (CFS) Board, presented the annual report from CFS. (Appendix 1.) A question was raised about the lack of detailed financial information which we decided at the March 2019 MWAB to include in annual reports. Another suggested we revisit this policy and reconsider it. Another suggested, given the pandemic, we make an exception this time. A long discussion ensued. We accepted the report with gratitude. We agreed to revisit the policy about the request for financial information. Carolyn Stuart, Hank Elkins, Faye Stanley, Monteze Snyder and Naveed Moeed agreed to serve on a task force to do so.

5. The Quaker House annual report will be postponed until February.

6. Maura Murphy, Treasurer, presented the first quarter financial report. (Appendix 2.) Due to the pandemic, we cut our budget significantly this year. We are a bit behind in contributions and more are needed at this time. Regarding our obligations, we are on track. Some committees have not turned in receipts for expenditures made. Finance Committee is over budget. Our treasurer needed more accurate help for payroll and subscribed to accounting/tax help. The old laptop died and a new laptop was purchased. We are ahead in our net ordinary income. We get a tiny bit of interest from BB&T and a payout from Friends Fiduciary that goes to the Shotts/Leadership Development Fund. Our benevolences have not been paid yet as they are usually distributed in April. We accepted the report with gratitude.

A question was raised about the process for deciding when to return to the Meetinghouse. The Clerk explained that this question is under the care of the Ministry & Worship (M&W) Committee and discussed monthly. He will ask M&W to provide a regular summary report. M&W will make a recommendation to MWAB at the appropriate time and MWAB will make a decision.

7. Alice Carlton, CHFM Representative to Piedmont Friends Yearly Meeting (PFYM), presented the Spiritual Condition Report to send to PFYM by the end of January. Our report will be compiled with similar reports from other members of PFYM to be shared at the Annual Sessions in April. The report was accepted with gratitude. (Appendix 3.)

8. Jeff Brown, Clerk of M&W, presented a recommendation for the transfer of membership of Tim Fogarty from Gainesville, Florida to CHFM. (Appendix 4.) We approved this recommendation with joy.

9. The Clerk presented the Discernment Statement about the Rooftop Solar Proposal. (Appendix 5). "We are not in unity now and unlikely to find unity on this proposal soon and that the current process is having a deeply harmful effect on us as a Quaker community. It is time to set the proposal aside and to refocus on supporting each other more fully." Due to the lack of time left in our meeting, few were able to express their opinions.

10. Next MWAB will be 9 am, Sunday, February 21, 2021.

Appendix 1

Carolina Friends School Annual Report to CHFM, Meeting for Worship with Attention to Business January 17, 2021

The year 2020 was dominated by the Covid-19 pandemic and its far-reaching challenges never before imagined by the school community. These many issues and concerns have demanded unique solutions and are successfully being met by the staff, students and trustees.

The teaching staff has mastered new teaching methodologies with the accompanying technologies, all without losing sight of the importance of centering and developing the whole student. In addition to holding on-line classes the teaching staff regularly schedule one-on-one sessions for each student. The level of attention to the care of all students, both those in class and remotely learning has been awe inspiring, but has come at a great cost to the teachers. The Board members have been concerned and tried to show our gratitude. One effort had board members writing a thank-you note to an individual teacher. These were delivered in small treat bags, and were warmly received. It was a small but meaningful gesture for these dedicated educators.

In addition to working to keep everyone safe the Board and the staff have gone to great lengths to hold on to the existing school families through financial support. Fortunately, the financial status of the school is healthy because of wise and careful stewardship. However, the new pandemic-era demands required utilizing funds from different and unexpected sources, such as the federal Paycheck Protection Program loan, which is expected to be forgiven. The School has implemented an emergency fundraising campaign for \$2 million to meet immediate Covid-19-related needs, both for financial aid as well as for the physical plant, and additional staffing. Thirty percent of this goal has been raised by the skilled and dedicated Development staff and volunteers. The trustee Advancement Committee has also created a "Fundraising Guided by Quaker Principles" manual.

Due to the current surge of the pandemic, all students are in remote learning since the end of winter break. The school leadership must constantly assess the situation and make adjustments to best meet the needs and safety of the students, teachers and parents. When the school is holding in-person instruction, it uses what is called the 'Lasagna Approach' to safety: daily on-line screening including temperature checks; sanitizing classrooms and equipment throughout the day; and improved air filtration in heating & cooling systems. Also, a full-time nurse has been hired. Classrooms have been configured to keep social distance, and an additional multi-classroom modular unit is being installed for the upper school. A minority of students remains remote learners and the school has made accommodations for them, including hiring additional staff. Through these and others solutions the Quaker value of caring and honoring our community has been evident.

Amidst these changes ongoing social justice issues are being seen and felt, and addressed by the school staff and board. The CFS Board has initiated a Diversity, Equity, Inclusion and Justice Committee. All trustees are attending the Racial Equity Institute trainings. The Peaceful Schools program remains active.

The CFS community is blessed to have Karen Cumberbatch as our school head, especially during this school year's pandemic and civil strife. Her caring and insightful communications to the community are outstanding. Below is a statement she sent to parents and teachers after the violent events in Washington DC on June sixth:

To the parents: "I am grateful that we are a community that has the vocabulary, commitment, and capacity to engage deeply with students in such extraordinary circumstances. We have scheduled an All-School Meeting for Worship for 4 pm tomorrow (Thursday) to create a space for collective reflection.

To the teachers: "It is during times such as these that we as educators are called to find the resilience and capacity to ground ourselves so that we can help support the needs of our students. I recognize it is not easy to do this when we are each still processing so much... Let's call on each other for help."

The School community has come together for the best interests of the students and the continuation of our Quaker values-based school. It was best said by a non-Quaker board member recently: "We came to this school thinking the main concern was to develop our children's minds but I have come to understand that developing and instilling the skills, sense of service, conflict

resolution, caring for a world community are the most important things we learn here. I was not taught this as a child and do not see it being taught at most schools. This is why this school is important”.

Here at CHFM, the three current appointees have been wrestling with our roles and the relationship between the Meeting and the School. We have appealed to the Ministry and Worship Committee because our group is not "under the care of" any specific Meeting Committee. To insure Quaker values and traditions are fundamental and on-going to the School, the Meeting-appointed CFS trustees are asking for help in discernment how to strengthen and practically implement these over the long-term. Hopefully we can report on this in our 2021 annual report.

Finally, we can report that the budget and actual expenses are shared with the trustees on a regular basis and the School's audit has been accepted without qualification. We have no concerns at this time concerning the financial accountability of the school, and as stated above, the School's finances are fundamentally healthy.

Spiritual Condition Report for Piedmont Friends Yearly Meeting

Chapel Hill Friends Meeting 2020

Friends at Chapel Hill Friends Meeting (CHFM) have experienced the working of the spirit in many ways. We appreciate more the things we can still do during the pandemic, such as meditating, connecting with nature, praying, especially for friends and family, reaching out to longtime friends (non-Quaker) to reconnect, even requesting membership to CHFM. We have slowed down, taking time to breathe and appreciate what is there, to calm ourselves so we can feel the spirit working within.

The biggest challenge remains keeping our meeting connected. Some aren't comfortable using Zoom. Our Care and Counsel Committee has reached out to all members and attenders by phone to offer any needed support. The Ministry & Worship Committee sent out a helpful email survey to assess how members and attenders feel about Zoom and assess what spiritual guidance is needed. Considering major decisions in Meeting for Worship with Attention to Business over Zoom is a major challenge.

Using Zoom with First Day School (FDS) is tough. For the most part, the children are weary of gathering virtually, even though they often end up having fun after their parents force them to attend. The Children and Youth Religious Education Committee (CYRE) is trying hard to be creative (movie nights, offers to change FDS time) to reach students and allow parents to attend worship, but it's been slow going. Our parents seem overwhelmed with home-schooling and coping with the isolation and grumpiness of their children. Some parents have expressed interest in gathering in person outside while others have concerns for health and safety. The teens have met at different times with different activities to boost attendance.

We are having ongoing discussions about when and how to safely reopen the Meetinghouse for in person worship. Communications with the Meeting as a whole can be difficult. There are wide ranging opinions, and we are far from unity.

Holding Wednesday evening Prayers for Healing/Holding in the Light is meaningful for some Friends. The breakout rooms for small group fellowship after worship allow us to get to know Friends we didn't know or to enjoy getting to know better those we did know. Many of us are concerned about climate issues. The possibility of installing solar panels is being considered. The efforts to deepen our lives in the Spirit during this challenging time matter a lot to our Meeting.

Our Peace & Justice Committee (P&J) has made focus on racial justice a priority, despite the COVID-19 limitations on our response. Nevertheless, we approved a letter regarding racism that we labored long over. In addition, there is a book group forming on racism and social justice. Also we worked to encourage voting, in light of knowing about NC counties that restrict minority voting. Some attended the local school board meeting to speak against arrests of students when in school. Our Transition and Support Committee helps men released from Orange Correctional Center (OCC) to adjust to life back in the community. We announced the Racial Equity training and offered financial support (via Shotts/Leadership Fund) for those who wished to attend. Monthly queries, Forum topics and Friends Journal readings on social equity all serve to encourage personal reflections. We miss the presence of the OCC visitors who cannot attend worship during the pandemic. We are concerned about the disparities made worse by COVID-19 as well as the welfare of pre-school children in NC. We hope and pray that these will be addressed after the pandemic is under control.

We appreciate Zoom for the connections it provides to Piedmont Friends Yearly Meeting (PFYM) and other Meetings throughout the US and world-wide. Sharing with other PFYM meetings is helpful. What are other Meetings doing on the topic of racial injustice? How can we encourage more People of Color (POC) to attend our Meeting? We understand the need to meet folks where they are and not expect them to join us by becoming like us. Could we pair with a sister church different from us as we did thirty years ago? We noted with sadness that our own POC rarely attend Zoom worship now. We wonder what other meetings are doing in regards to hybrid worship as we consider safe return to our Meetinghouse.

Other concerns include the lack of Adult Young Friends (AYF) in Meeting. How can we encourage them to attend? We also wonder how to encourage vocal ministry with Zoom worship compared to in-person worship.

We certainly miss being in the Meeting House in the presence of others, miss the children and youth and miss the men from OCC. We appreciate Zoom for keeping us together during these times.

The Clerk received a letter from the Gainesville (Florida) Monthly Meeting on December 15. Appendix 5

Chapel Hill Friends Meeting has been considering a proposal for Rooftop Solar for many months. The proposal was prepared by a subcommittee authorized by the Meeting and has been endorsed by several committees. Many individuals are very much in favor of proceeding and have expressed their willingness to support the project financially. However, the Meeting is NOT in unity with the Rooftop Solar proposal.

Friends who do not support the proposal have a variety of reasons. These include:

- The uncertainty of financial needs, community and individual, related to the pandemic
- Uncertain expenses and effort needed to return to worship together, which is seen as a priority
 - Reluctance to begin a capital campaign in the current situation
- Belief that the proposal centers on CHFMs exclusively and is not based on our testimony to community
- Project benefits are more financial than ecological, where environmental action was the original intention
- Concern that other projects of benefit to the environment have not been adequately considered

A very significant portion of our community does not support the proposal now. It is not one or two individuals standing in the way. Exchanges between community members during the discernment process have become increasingly hurtful and divisive. This replaces the deep listening that is our goal, and harms our community. For this reason, both the Ministry and Worship Committee and the Care and Counsel Committee have been engaged to provide the Clerk with support in discerning the sense of the Meeting regarding the Rooftop Solar proposal.

As Clerk, my sense of the Meeting is that we are not in unity now, that we are unlikely to find unity on this proposal soon and that the current process is having a deeply harmful effect on us as a Quaker community. It is time to set the rooftop solar proposal aside and to refocus on supporting each other more fully. Discussion of this proposal will not be included on the agenda for Meeting for Worship With Attention to Business for at least several months. It is possible that our Meeting may decide to re-engage with this proposal in the future. If the proposal is reintroduced, that discussion should begin with a clear statement of the goal of the project, and unity should be found on that goal first, so we can work together toward the best way to achieve it.

This discernment has been reached with the support and counsel of the Ministry and Worship and the Care and Counsel Committees.
