Small Group Worship at the Meetinghouse

After listening carefully to our community and giving thoughtful consideration to ways to meet the needs of our community, the Ministry & Worship Committee received permission from the Meeting to begin offering responsible opportunities for small group worship in a variety of settings. We invite the Chapel Hill Friends Meeting community to try and help us evaluate options for small group worship over the coming weeks.

In this unprecedented time, the committee is not pursuing the perfect answer to how to worship together, and we do not know the lowest risk way to proceed.

Note: To promote safety and reduce the possibility of Covid 19 transmission and infection, the completion of **vaccination protocol** and the **wearing of masks** around others on meeting property is lovingly expected. A risk assessment tool is available as well (<https://www.microcovid.org/tracker>). To keep the small group worship simple, there will be no refreshments available (bring your own water), indoor participants will be urged to go outside at the rise of meeting to limit time in the building, and the building will be closed between early and late meetings. Friends are asked to not go downstairs (except for the nursery), for simplicity in preparation and maintenance of safe spaces..

Children older than 3 are encouraged to attend the first 15 minutes of worship and will be led down to the playground for First Day School, which is on the playground during Covid. However, there will be at least one adult on the playground starting at 11:00 for those who are nervous about indoors. For children under 3, the nursery is open downstairs if needed.

Help End the US-Supported War in Yemen

Please support FCNL's Emma Hulbert and FCNL's Chapel Hill Advocacy Team (Joe Groves, Tom Munk, Ellen O'Brien, and Curt Torell) in an attempt to end Saudi Arabia's brutal war on the people of Yemen. Exciting news! After months of advocacy and lobbying by FCNL, our Advocacy Teams, Yemeni activists, and countless others, lawmakers have finally introduced a Yemen War Powers Resolution in the House of Representatives! This is a massive step towards ending the war and Saudi-led blockade of Yemen.

While the momentum for lasting peace is building, the passage of this legislation is not guaranteed. Your voice is more crucial than ever in Yemen's push for peace.

With critical help from the United States—including maintenance and logistical support for warplanes—the Saudi-led coalition has killed nearly 400,000 Yemenis. The seven-year war and blockade have caused famine and acute food insecurity among 19 million people.

The Yemen War Powers Resolution (H.J. Res. 87) is a bipartisan effort to end U.S. support for this war. By making it clear that Congress won't allow any more U.S. military support for Saudi Arabia, this legislation will provide further incentives for the warring parties to stay at the negotiating table.

1. Carolyn Stuart, Acting Clerk opened the meeting with worship and read the Query – How do I faithfully attend Meeting with heart and mind prepared for worship, clear of any predetermination to speak or not to speak, and expecting that worship will be a source of strength and guidance?

2. Carolyn welcomed Friends, recognized David Waterman as a first-time attender, and reviewed agenda.

3. Susan had prepared the minutes of the May Meeting for Worship with Attention to Business (MWAB). With consideration, Friends approved the minutes.

4. Carolyn reported on the memorial service for Jackson Alguire Vickery, which took place on June 11, 2022 at Historic Mordecai Park in Raleigh in good order under the care of the meeting. Carolyn read a message from his mother Catherine Alguire and asked that we continue to hold the family in the Light. Carolyn then asked that we continue to hold the family in the Light.

5. Deborah Gibbs presented the proposed roster of committee members and others who serve the Meeting during the May MWAB. Gwynne referred to that roster and pointed out updates since last month. The updated roster is included here as Appendix 1. Friends approved the proposed roster recommended by the Nominations Committee.

6. Monteze Snyder, Clerk of the Finance Committee, presented the draft budget for the coming fiscal year during the May MWAB. Monteze pointed out an update on the budget for Finance Committee. The updated budget is included here as Appendix 2. Monteze responded to questions and clarified that the budget includes contingency funds, such as for Communications, which we may or may not need to spend given that we do not yet have clarity about whether we will need equipment and technical support for a hybrid meeting. The budget is built on committee requests, but expenditures are approved and occur separately. Friends approved the proposed budget recommended by the Finance Committee.

7. Leslie Rountree, our Representative with Ann Miller to the Piedmont Friends Yearly Meeting, presented the PFYM annual report that was postponed from last month. It is attached here as Appendix 3. Leslie responded to questions. Friends approved the report with appreciation.

8. Jasmine McKewen, our Representative to the Piedmont Friends Fellowship, presented the PFF annual report that was postponed from last month. It is attached here as Appendix 4. Friends noted that both the PFYM and the PFF meetings were hybrid and that it was a successful mechanism. Friends approved the report.

9. John Bell, one of our Representatives on the Carolina Friends School Board, presented their annual report. It is attached here as Appendix 5. John added that he will report information on employment and contributions at the next MWAB. Carolyn noted that the Benevolences Committee had requested that information, from all recipients of our benevolences. Julia, who also serves on the Board, commented that there are also several sub-committees working on the challenges of compensation and their work will be presented in the fall. Friends approved the report with appreciation.

10. Dottie Heninger presented a proposed memorial minute for Wade Barber. It is attached here as Appendix 6. Friends commented in appreciation and accepted the minute.

11. Jeff Brown, Clerk of the Ministry and Worship Committee provided an update on the status of blended worship and returning to face-to-face worship, as well as the recent listening session. It is attached here as Appendix 7. Friends acknowledged that Zoom and the hybrid experience has both advantages and disadvantages. Average attendance at early meeting is about 6; attendance on Zoom averages 18-31; in-person in the Meeting House averages 20-30; in person outdoors at the Meeting averages about 5; and worship at Carol Woods averages 8 or so. Friends expressed appreciation for how the committee has maintained and monitored the options for worship and accepted the update.

11. Carolyn announced that there will be no MWAB in July. The next MWAB with attention to business will take place on August 21, 2022.

Appendix 3

Piedmont Friends Yearly Meeting (PFYM) Representatives Annual Report Sixth Month, 2022

Chapel Hill Friends Meeting (CHFM) representatives have met with the body of PFYM representatives quarterly since the annual sessions of the Yearly Meeting on the tenth day of the fourth month in 2021. At each of these interim meetings, PFYM continued its work to nurture its member meetings and the greater Friends community despite the continuing challenges brought by the Covid-19 pandemic.

Many of these challenges have also afforded us unique opportunities. Our reliance on virtual zoom meetings throughout the year gave us a chance to plan for and provide fellowship and spiritual care for our member meetings. For example, outside of interim meetings, PFYM has continued to host Member Meeting Clerks Calls, where clerks can share updates and concerns from their meetings, informal conversation, and building connections.

In early November, PFYM Friends began considering moving to a clerking committee as an alternative to finding an assisting clerk who would rise to presiding clerk. The February Interim Meeting approved the proposed clerking committee as the leadership structure for PFYM, with Sally Freeman and Paul Klever of Eno Meeting, Marian Beane of Charlotte Meeting, and Nancy Riemer of Raleigh Meeting as members.

Broader changes were also in the works. In December, member meetings received a proposal for the unification of Piedmont Friends Fellowship and Piedmont Friends Yearly Meeting, and were asked to help facilitate their meeting's discernment prior to a scheduled March 5 joint meeting of PFF and PFYM representative bodies. At the joint meeting of the PFF Representative Body and the PFYM Interim Meeting considered the feedback received from various meetings and approved a minute recommending unification:

"Friends are in unity to recommend to PFF & PFYM unification of the two bodies into Piedmont Friends—Yearly Meeting & Fellowship, with core values of inclusivity, fellowship and peace building and with a sense that unification can be strengthening for Piedmont Friends."

The joint meeting also approved an Interim Clerking Committee, an Interim Nominating Committee and joined their ongoing work into the Interim Unified Representative Body.

On a beautiful and joyous Saturday in early June, PFYM and PFF held their joint Annual Sessions on the Guilford College Campus for the first in-person meetings since the pandemic began. Chapel Hill Friends Meeting was well represented. In their respective business meetings, the two organizations were officially laid down, and the unification of the two bodies into the Piedmont Friends Yearly Meeting and Fellowship was then approved by all. An epistle from the Annual Session is forthcoming this summer.

Looking forward, Piedmont Friends have set the following priorities:

1. Continue holding in our spiritual care the development of the Adult Young Friends community within Piedmont Friends.
2. Continue holding in spiritual care the work of FCNCL.
3. Hold in spiritual care and hosting of the 2022 FGC Gathering.
4. Increase outreach of the Yearly Meeting within member meetings, building understanding of the Yearly Meeting as a bridge to the larger world of Friends.
5. Survey smaller Meetings within PFYM for ways we can offer them support.

Member Meetings of Piedmont Friends include: Abingdon, Celo, Chapel Hill, Charlotte, Durham, Eno, Fancy Gap, Fayetteville, Friendship, New Garden, Raleigh, Salem Creek, Swannanoa Valley, Upstate Friends Worship Group, and Wilkes County Friends.

Appendix 4

Piedmont Friends Fellowship Annual Report to Chapel Hill Friends Meeting June 2022

This annual report includes excerpts from the 2022 Piedmont Friends Annual Sessions documents. Jasmine McKewen serves as CHFM representative to PFF. Jeff Brown serves as interim recording clerk for the Representative Body.

PFF representatives met jointly with PFYM in August 2021 and separately in January and March 2022 on Zoom. In June 2022 PFF met jointly with PFYM for the first time in person since the beginning of the pandemic. The in-person portion of the annual retreat was held at Guilford College.

The theme of the annual retreat was “Radical Hospitality—Welcoming the Light in Others.” The retreat began with online conversation guided with queries by Deborah Bromiley and John Shuford on Friday evening. Saturday included fellowship and morning refreshments; guest speakers Leah and Jonathan Wilson-Hartgrove from the School of Conversion, the Poor People’s Campaign, and Restorative Justice Durham from the Religious Coalition for a Nonviolent Durham; a presentation by president of Guilford College Kyle Farmbry; fellowship over lunch, a walking history tour with Max Carter; the annual sessions; a book sales table with books from FGC and Piedmont Friends; and fellowship of Adult Young Friends over dinner. The retreat concluded with online meeting for worship on Sunday morning.

The main work of this past year has been the unification of Piedmont Friends Fellowship and Piedmont Friends Yearly Meeting into “Piedmont Friends—Yearly Meeting and Fellowship,” combining organizational functions and leadership and maintaining core values of inclusivity, fellowship, and peace building. The meetings of PFYM are designated as “Yearly Meeting” members and PFF meetings not currently members of PFYM are designated as “Fellowship” members of the joint body. Regardless of affiliation, all meetings are invited into the unified work of “Piedmont Friends—Yearly Meeting and Fellowship.” This includes representation to larger Quaker organizations, appointing representatives to quarterly/interim meeting, annual spiritual condition reporting, participating in various workshops, presentations and meeting clerks’ calls, and participation in annual retreat and annual sessions.

Functionally, Piedmont Friends will now have one representative body, one annual meeting/sessions, one leadership group, one set of representatives to Friends organizations. The unified body will continue to plan the spring and fall retreats for fellowship and support, offer opportunities for member meetings and individual Friends to share information and concerns, maintain the shared website, as well as opportunities to participate in the wider work of Friends.

At the annual sessions this month, Friends acknowledged the more than fifty years of Piedmont Friends coming together in fellowship, in support of peace building, and in welcoming inclusivity. Building upon this foundation of collaboration, Friends affirmed the unification as strengthening Piedmont Friends into the future.

Appendix 5

Annual Report from Appointees to Carolina Friends School Board of Trustees, to the Chapel Hill Friends Meeting, June 19, 2022

The **overall status** of Carolina Friends School, both as an organization and a community, is healthy, although not without stresses. This assessment has been made somewhat more complicated by Trustees’ avoidance of being on campus in-person because of the pandemic, in addition to the intentional distance trustees keep from daily operations, individual student

experiences and personnel matters.

As in nearly all schools, the past eighteen months of the **Covid pandemic** have been demanding on students and their families, more so on some than others. Thankfully the School as a whole has been *relatively* safe from widespread infections and School life is improved as it has gradually returned to near normalcy.

In addition to the difficulties and demands placed on our students in the past 18 months of this report, **CFS staff**, especially teachers, are tired, having suffered from the hardship of implementing the necessary public health protocols and from their impact. For a variety of reasons (see financial needs, below) staff turnover has been higher than in previous periods. This is also increasingly true of the profession generally. As a result, the process of advertising, interviewing and hiring have been a larger than usual time-consuming necessity. During this year Head of School Karen Cumberbatch hired a new finance director and is in the final stages of hiring a Head of the Upper School, both senior positions. Currently there are fourteen full and part-time openings listed on the website.

The school's **Quaker character** remains strong and is highly valued by students, staff and trustees. The board has a committee focused solely on this. This past spring the Committee held a session for incoming families to inform them about Quaker values and traditions, another effort has been initiated for new Trustees (see **diversity, equity and justice** below), and the Committee wished to hold a third for students but it has been postponed until the autumn of 2022. The Advancement Committee – a combination of staff, trustees and volunteers - has agreed upon a policy of "Fundraising Guided by Quaker Principles". Trustee appointees have requested help from Ministry & Worship on how to strengthen and implement Quaker values and traditions.

The School has long-term **financial needs**, in particular increasing staff salaries, which historically have been below public school teachers' salaries, which are themselves low. There are five board/staff committees analyzing overall salary levels and benefits which have been unable to conclude their work because of the pandemic's disruptions. To address this there have been internal discussions about conducting a future **capital campaign** to further strengthen the School long-term. Needs include teacher salaries, a new or significantly renovated/expanded upper

school building, items identified but not addressed during the previous capital campaign, and raising a larger endowment. These and other options will be considered.

The School is now in its 60th year. Because of the School's size, age, its assets and complexity, **governance** is undergoing a number of needed changes, becoming better organized, documented, professional and policy-focused. This has been a positive process.

Regarding **diversity, equity and justice**, the School has had a particularly painful year. Three Trustees, two of whom are people of color, and all members of what was previously called the DEI Committee, resigned within five months. Although there were many conversations and a concluding committee report, there is not a consensus as to what caused these resignations. Nonetheless, as a result there has been much trustee and staff leadership soul-searching, the creation of a board committee to plan and institute a more robust trustee engagement of this matter, review of trustee nomination, appointment and on-boarding processes, and the hiring of a DEI consultant to assist us in discerning and beginning our next steps.

Despite these challenges graduation on June 12th was a proud and joyful occasion. We appointed Trustees are grateful to have the responsibilities we do, for Carolina Friends school as an institution, and for the young lives of our students, as well as their families, the staff and our fellow community members. We ask the Meeting to hold the entire School community in the light as it begins summer's rest and recreation, formal summer programs, and preparation for a new school year.

Memorial Minute for Wade Barber
Wade Barber, Jr.

February 11, 1944 – May 13, 2022

Wade Barber began attending Chapel Hill Friends Meeting about 1995. He continued to join us in worship over the years, returning each time to a favorite seat in the meeting room. Through the pandemic he attended via Zoom. Wade served on and then clerked the Buildings and Grounds Committee from 2000 to 2006. He was very pleased when, ten years later, the Meeting began a renovation of the meetinghouse. Wade's unique contribution to the renovation was to repair and refinish one of the benches. In 2018 he provided valuable guidance for an extensive report on the roles and responsibilities of the Meeting trustees.

Throughout his professional career, Wade embodied the thoughtful integrity of a Quaker. As a lawyer, he is remembered for his empathy, compassion, a willingness to try to understand another person's burdens, an ability to guide a person through deeply challenging times, and humility. He evidenced a deep respect for the dignity of each individual. He was appointed District Attorney for Chatham and Orange Counties in 1977, and in 1998 he became a judge of the North Carolina Superior Court, ending his public service as Senior Resident Superior Court Judge in 2006. Wade then opened a legal practice in his Pittsboro hometown. Eventually, his daughter Liz joined him to form the firm of Barber and Barber.

Wade married Marina in 1976. Their two daughters, Claire and Liz, and their son James Riley were their joy. Wade later found delight in amusing his six grandchildren.

Wade Barber was inducted into the Order of the Long Leaf Pine, one of many prestigious awards he received. North Carolina was proud to call him a son. Chapel Hill Friends Meeting was glad to call him a Friend.

Wade died from ALS. A memorial service, coordinated by the Meeting's Care and Counsel Committee, was held for him on May 16, 2022 in the sanctuary of the United Church of Chapel Hill. The memorial service in the manner of Friends enabled the sharing of many heartfelt messages honoring Wade.

Appendix 7

June 2022 Report from Ministry and Worship Committee (M&W)

on the Status of Worship to the June 19 Meeting for Worship with Attention to Business

Small group worship on First Day continues in a variety of settings—inside the meetinghouse at 8:15 and 11:00 AM, outside around the right side of the school building at 11:00, by Zoom at 11:00, and at Carol Woods at 11:00. Friends decide for themselves what First Day option best meets their needs for safety and well-being.

According to the CDC, Covid community transmission in Orange County remains high. M&W recommends continuation of enhanced ventilation in the meeting room and masking in the meetinghouse. Reminder: N95 or KN95 masks are available at the meetinghouse.

The Ministry & Worship Committee plans two changes in worship options starting June 12. Please take note as you choose your worship opportunity. (1) The number of window fans bringing in fresh air will be reduced by one fan on opposite sides (street and playground) and speed of all fans will be reduced from high to medium. Masks are still required except for vocal ministry. (2) Outdoor worshipers may remove masks during worship if comfortable doing so. Also, M&W may not have a closer available for outdoor worship this summer when members are away.

Ministry & Worship is trying these changes to support better hearing in the meeting room while continuing to keep air flowing in and out of the room. The committee will continue to monitor attendance and practice in the meeting room.

Note that masking of children on the playground is at the discretion of the Children and Youth Religious Education Committee.

The blended meeting trial on May 22 went well, with thanks to the Zoom Subcommittee, and Quaker Harmon in particular, for skillful application of borrowed equipment in the meeting room. Subcommittee members also supported the gathering of Piedmont Friends in blending Zoom with an in-person program on June 4 at Guilford College.

The Ministry & Worship Committee (M&W) “supports the spiritual life of the Meeting. It also fosters understanding of Friends’ principles and practices, working collaboratively with other committees... (and it) nurtures other committees that do the Meeting’s work.”

For those purposes, M&W held a listening session on Zoom on June 1. The session was attended by 38. Out of worship, more than a dozen Friends shared perspectives on the Chapel Hill Friends Meeting (CHFM) faith community and the work of the Meeting. Friends gave spirit-led messages, too many to include in this report, including these encouraging descriptions of our community:

1. Faith-based with space and energy for spiritual growth
2. Loving community that supports worship and work
3. Beloved community and spiritual home
4. Intertwined spiritual home and action based on love, justice and solidarity
5. We enter into worship and leave to serve
6. A place to listen to the inner voice/Spirit/God
7. A space for voices to be heard

The committee would like to offer a follow-up listening session in July, to be announced. All will be invited to listen and share understandings of ways to do the work of the Meeting, and ways to love one another in the context of Quaker faith and practice, with respect, trust, sharing and deep listening.
