Join us **June 7th at 11 a.m.** to learn more about Ramallah Friends School and its work. Rania Ma'ayeh, Head of the school will share its history and the essential role it plays in the lives of the students, teachers, and community. How can we, Quakers, support this important work by Palestinian Friends?

The Ramallah Friends School is a living testimony to Quaker values on the West Bank. Children there learn that every person is beloved equally by God and that our words and actions must reflect our truest selves.

The school is a <u>fixture in the cultural and educational landscape of Palestinian society</u>. Dating back to the 19th century, RFS has played a significant role in the development of a liberal, tolerant, and economically viable community. Despite political and regional challenges, RFS graduates have been instrumental in creating lasting positive change as leaders in Palestine

and around the world. This is despite facing the huge challenges of living on the West Bank. As Friends United Meeting shared in their report from a recent pastoral care trip:

The team heard first-hand accounts of how settler violence is increasing. It is not unusual for Ramallah Friends School staff and students to be harassed to and from school." Progress and resilience continue to distinguish RFS as an "oasis of hope" for the Palestinian people.

The 98% - Life After Prison

Tom McQuiston shares with Friends:

Many at Chapel Hill Friends Meeting know the many friends who visit our meeting from Orange Correctional Center, the State's minimum security prison in Hillsborough. The Meeting's Transition and Support Committee would like to introduce to you a podcast, "The 98% - Life After Prison," by Judy Van Wyk and April Barber Scales. This podcast is dedicated to the people incarcerated in North Carolina who will eventually be released from prison back into their communities, often with few, if any resources.

Through the voices of people in transition and those who support them, the podcast explores hurdles and life long barriers many justice-involved people confront whether getting a driver's license, finding housing, or trying to find a job. Judy and April examine issues like substance use disorder and mental health that plague this population and ask what we as a society can do to support the formerly incarcerated and reduce recidivism.

In 2023, Judy and April partnered to create the podcast about the many issues people face when transitioning from prison. Judy is a producer and criminal justice advocate. April received a life sentence when she was 15. After more than 31 years, she had her sentence commuted by Governor Cooper. She was released March 24, 2022.



Chapel Hill Friends Meeting Minutes of the Meeting for Worship with Attention to Business, May 18, 2025 on Zoom

- 1. We opened with worship and the query, "How do I experience the Quaker testimony of continuing revelation?"
- 2. We welcomed Barry and Linda MacKichen as first-time attenders.
- 3. We approved the minutes of the April 2025 Meeting for Worship with Attention to Business (MWAB), with one revision. The minutes were revised to spell out ICE and UNRWA: Immigration and Customs Enforcement (ICE) and United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA).
- 4. John Hite presented the Nominations committee's annual report and proposed committee slate for the coming year (<u>Appendix A</u>). Friends offered suggestions for revision, which are now incorporated in <u>Appendix B</u>. Approval of the final slate will be considered at the June MWAB.
- 5. Dottie Heninger presented a revised version of the Benevolence Process document on behalf of the Ministry and Worship Committee (Appendix B). The original version of the document was created by an ad hoc committee 5 years ago. In response to the document, a Friend raised the question of how we address changing needs over time and outside the annual budgeting process, for example when Quaker House needed a new roof. Friends affirmed the importance of ongoing engagement with the organizations we support to understand their needs and noted that we have the opportunity to support organizations outside the Meeting budget through fundraisers and individual contributions. One Friend called us to work towards a more unified and celebratory approach to our giving as a Meeting. A Friend raised a question about how members for the new of Ad Hoc committee would occur. Ann Miller suggested that the Clerk might invite committees to consider who might be on the ad hoc committee and then bring to MWAB for approval. The suggestion was made that the process of elicitation be outlined in the Benevolence Process document. Dottie Heninger will add a sentence clarifying the process to the document. Approval of the revised document will be considered at the June MWAB.

- 6. David Waterman, Finance committee co-clerk, presented the proposed fiscal year 2025-26 budget (<u>Appendix C</u>). Approval of the budget will be considered at the June MWAB.
- 7. The next Meeting for Worship with Attention to Business is planned for 9:00 AM on 6/15/2025.

8. Announcements:

- Publications and Communications is starting a new occasional section for our e-news and newsletter. It's called Quakers in the World and provides opportunities for Friends to support other Friends engaged in Spirit-led activities such as musical, theatrical, dance, or athletic performances, celebrations, protests, lobby visits, or spiritual gatherings.
- Friends were encouraged to attend the Piedmont Friends Retreat and Annual sessions: May 30 through June 1. The session on May 31st will be in-person at Guilford College.

Appendix A: 2025 Annual Report of the Nominations Committee

The Nominations Committee seeks to identify and call forth the gifts and talents of attenders and members of our Meeting for service within the Meeting and in the larger community. Throughout the year, the committee works with other Meeting committees to identify the interests and skills needed for committees to fulfill their missions. The committee initiates the search for nominees, often asking other committees and individual members of the Meeting community to help identify likely candidates. The Nominations Committee seeks to align the gifts and interests of individuals with the work of Meeting committees and of organizations receiving Meeting appointees.

The Committee brings nominations for vacancies in Meeting committees and appointees for the next program year (July-June) to the May Meeting for Worship with Attention to Business (MWAB) for review. Nominations presents a final report to the June MWAB.

Nominations also finds appropriate members and attenders to fill position vacancies as they occur. The Committee reviews the Recording Clerk, Treasurer, Recorder, Correspondence Clerk, and Trustee positions as the terms are due to be completed. The Committee also organizes a discernment process to recommend a new Meeting Clerk every three years prior to completion of the clerk's term.

Vacancies on the Nominations Committee are nominated each fall by a Naming Committee, identified by the Clerk and approved by the MWAB.

This year the Nominations Committee has filled seats on all committees where there were identified needs and instigated the process of finding a new Clerk. The Clerk Naming Committee's work is ongoing at the time of this writing. We have also continued to pay particular attention to the Peace & Justice Committee, with Care & Counsel and Ministry & Worship committees.

Our Current slate of nominees follows. Finance Committee needs another member. Interfaith Council, Peace & Justice, Friends Committee on North Carolina Legislation all have room for more friends to participate.

Appendix B: Benevolences: 5 Year Review of the Process

In the 2020 document outlining the benevolence process, it was stipulated that the process be reviewed in 5 years. It is time. Many things have changed in our Meeting and we trust that this current revision reflects the necessary updates. At the same time, we acknowledge gratefully the wisdom of the original document; we have borrowed from it. In the process of the ad hoc committee's work on the current year's discretionary benevolences, it was observed that some updates and revisions would improve the clarity of the Benevolence process document. Following the approval of the 2024-25 discretionary benevolences, the Ministry and Worship committee asked Jeff Brown and Dottie Heninger to continue their work by proposing revisions to the Benevolence process document. Ministry and Worship has approved this revision.

REVISION OF THE BENEVOLENCE PROCESS

Background:

We are deeply grateful that our Meeting shares so much of its income with others, often 35 to 40% of the total budget. We celebrate this ongoing commitment. Our benevolences reflect our faith and values and are an important way we express these to the larger community and the world.

Oversight of the benevolence process:

The Meeting for Worship with Attention to Business (MWAB) oversees the benevolence process.

<u>Legacy Benevolences</u>:

As a Religious Society of Friends, we lovingly support Quaker based organizations and organizations which reflect our values and testimonies, and with which our Meeting has a historic relationship. Fortunately, The Chapel Hill Friends Meeting can afford generous though modest gifts to a set of five legacy organizations.

We are grateful for the Meeting's support of five organizations: the American Friends Service Committee, Carolina Friends School, Friends Committee on National Legislation, Interfaith Council for Social Services, and Quaker House. We celebrate the fact that Chapel Hill Friends Meeting was instrumental in the founding of Carolina Friends School and Quaker House. In addition, Meeting members helped found the InterFaith Council for Social Services. The Meeting has provided financial support for each of these organizations for more than thirty-five years. We recommend that support of the five organizations continue. We further recommend that the current levels of funding at 80% of the benevolence budget be continued. The amounts for each organization will remain:

The Meeting for Worship with Attention to Business will expect to hear annual reports about each of the Legacy Beneficiaries. The reports should be made by a Meeting Friend active in or knowledgeable about the specific organization or a Meeting appointee to a board or committee of the Legacy Beneficiaries. The annual reports may highlight accomplishments and significant changes in the organization.

Discretionary Benevolences:

In addition to the Legacy Benevolences, Chapel Hill Friends Meeting continues to provide modest financial support for organizations that are immediately relevant to our membership. A total of 20% of the benevolence budget will be designated for these organizations. Early in the calendar year, MWAB will appoint an ad hoc committee to select these organizations. They will seek input from across the Meeting. They will discern the list of benevolences, with reference to the framework previously approved by MWAB: The benevolences "Must be either Quaker affiliated or local organizations that reflect our Meeting's values and with which Meeting members are closely affiliated." The ad hoc committee will bring these benevolences and recommended amounts to the March MWAB for approval.

Recommendations for the future:

We recommend that the Benevolence Process be reviewed in 5 years. If discomfort develops within the Meeting before that time, MWAB will discern if interim adjustments should be made.

Benevolences formerly under Ministry and Worship should be considered Meeting "affiliations" (i.e., membership in PFYM, FGC, Friends Journal, Friends for Lesbian, Gay, Bisexual, Transgender, and Queer Concerns), not benevolences.
