

How can I be a peacemaker in my daily life and in the world?

As peacemakers, we learn to move beyond a mindset that dehumanizes and demonizes the "other," seeking instead to listen, to feel compassion for, and to see ourselves in the "other," the "other" in ourselves. Compassionate Listening

is a practice that reaches deep into the heart of discord, teaching people to listen with a different "ear" to those around them.

Having compassion for oneself and others

Suspending judgment

Maintaining balance in the heat of conflict

Listening with the heart

Speaking from the heart with language that reflects a healing intention

Chapel Hill Friends Meeting Meeting for Worship with Attention to Business July 19, 2009

Opening Worship

The meeting opened with open worship on the following query: How well do we apply the testimony of simplicity to our individual lives, to the responsible use and the distribution of natural resources, and to the protection of the planet from the ravages of exploitation and pollution? Do we have reverent respect for all forms of life on the earth we share?

Approval

The meeting approved the minutes for the June 21 Meeting with a spelling correction to Ruth Zalph's name, and the addition of a missing parenthesis.

Treasurer's Report

Judy Purvis, treasurer, gave an overview of the meeting's finances, noting that the figures are not yet final for fiscal year 08-09, which ended on June 30, since not all bills, deposits, and reports have been received. Finance committee hopes to provide an end-of-year report in August.

Looking at "the 30,000 foot view" Judy pointed out:

- * Contributions are up. This reflects Finance Committee's extensive efforts to talk with members throughout the year and the multiple meetings for business that have focused on budget concerns.
- * Reserves are down like most everyone, the meeting was hit by the market decline. Reserves include the General Fund, the Bequest Fund, and the Physical Plant Replacement Fund.
- * Chapel Hill Friends Meeting met our budget for fiscal year 08-09, with a small surplus.

Looking at "the 10,000 foot view" Judy went on to explain:

* Total income for fiscal year 08-09 was \$81,886 (which includes about \$7,000 of football parking). As of the end of March, the meeting had taken in \$66,340. The contributions in the final three months of the fiscal year were considerably higher than the same months in the previous year, helping to account for the greater than expected income * Total Expenses paid out so far for fiscal year 08-09 are about \$53,400, with outstanding checks of around \$570. We still owe 50% of our benevolences (\$14,805), and \$3000 in internal transfers (\$1,500 to the leadership development and \$1,500 to the physical plant fund). If

you add all those together, it comes to expenses of about \$71,775, set against our total income of \$81,886.

- * The net surplus of ~\$10,000 was created by increased giving and by \$3,900 in unspent committee funds (including \$2,500 from YRE, which was not used because they raised so much from football parking and other donations)
- * The net surplus of \$10,000 includes money that can be used for the meeting's discretionary funds, which were to be funded at \$3,000 for the environmental concerns discretionary fund, and \$3,000 for the social action discretionary fund.

In a quick overview of our Reserves, Judy pointed out that:

- * We have lost some money in our reserves because of the market downturn
- * Some money that should be moved from reserves (bequest fund and physical plant replacement fund) to the general fund has not yet been moved because it involves selling shares, and currently that would mean taking a loss.
- * As of 3/09 the amounts in the funds were:
 - \$8,115 in the Bequest Fund (of which \$4,300 is scheduled to be moved to the general fund, leaving the remainder is to be used for the Spiritual Enrichment of the meeting, as agreed upon earlier.)
 - \$8,400 in the Physical Plant Replacement fund (of which \$3,000 is scheduled to be moved to the general fund)
 - \$8,900 in the general reserve fund.
 - These funds do not include money in the Leadership Development Fund, the Shotts Fund and the Care and Counsel Fund. These funds are not tracked as part of the Meeting's annual budget, but are overseen by other committees.

Based on this information, the Finance committee brought to the meeting two recommendations:

- 1. That we fully fund all of our benevolences (including internal funds such as the physical plant replacement fund and the two discretionary funds) for 2008-09.
- 2. That for our 2009-10 budget, we maintain the overall budget at \$68,000, recognizing that if contributions remain strong, we can always revisit the budget mid-year, but that \$68,000 is a conservative estimate about how much money we will be able to raise during the 2009-10 fiscal year.

<u>Friends approved these two recommendations, with thanks for the</u> work of the finance committee.

It was noted that neither discretionary fund had been actually spent in 2008-09 fiscal year, but if we agree to spend the money soon, it can be retroactively applied to the 2008-09 fiscal year budget. The Clerk also noted that the meeting needs to schedule a future discussion about the discretionary funds and how they work and whether we need to change our practices, based on questions that were raised in June.

Recommendation from Peace & Social Concerns for a Social Action Discretionary Grant

Hank Elkins, for Peace & Social Concerns, recommended to the meeting that \$2000 from the Social Action Discretionary Fund be used to support meeting member Ann Riggs in her ministry to serve as director of the Friends Theological College (FTC) in Kenya.

Hank Elkins read a letter from Ann Riggs describing her calling. One Friend brought and shared a written statement stating her inability to join with this concern because the college is supported by Friends United Meeting, which has a hiring policy that is discriminatory against homosexuals, a position with which our meeting disagrees. Other

Friends spoke about the need for kindness and caregiving and the fact that many groups whose policies we don't agree with nevertheless do excellent work in the world, which we can support. Other Friends spoke about the need to reach out and work with people we disagree with, and about Ann's excellent ecumenical work and the knowledge that Anne is not in agreement with the discriminatory hiring policy. Other Friends spoke of the great need for peace work and work on AIDS/HIV in Africa. Ann's letter, along with the letter written shared with meeting by one Friend, and other documents regarding this decision, are available online at www.chapelhillfriends.org/ARiggs/.

Because our meeting time was drawing to a close, the clerk expressed her appreciation for Peace & Social Concerns Committee bringing this forward, and for the thoughtful responses of those attending. The clerk asked members and attenders to contact Hank Elkins with additional questions, and asked the meeting to continue our discernment.

The meeting ended with a moment of silent worship.
