Book Review: "Memories of Muhammad: Why the Prophet Matters"

Book Review by Marilyn Dyer

Harper-Collins recently published "Memories of Muhammad: Why the Prohet Matters," which was written by Omid Safi, Ph.D., professor of Islamic Studies at UNC-Chapel Hill. Dr. Safi specializes in Islamic mysticism (Sufism), contemporary Islamic thought, and medieval Islamic history. He is chair for the Study of Islam at the American Academy of Religion and a member of the advisory board of the Pluralism Project at Harvard University. Additionally he is editor of "Progressive Muslims," which contains a diverse collection of essays by and about Muslims seeking reform within the tradition. The book has been described as the definitive biography of the founder of Islam, engaging as it does the interests of those with little knowledge of Muhammad (or the Qur-an) as well as those with more extensive backgrounds. The author's considerable knowledge of and appreciation for the two other Abrahamic religions enhance his writing. In reading the book, one is not only learning so much from this scholar but one is aware of being in the company of a wise man, deeply spiritual, a seeker of peace. This is a book we need to add to our Quaker Library.

The author was born in Jacksonville, Florida, but was reared as a child in Iran during the 1970s and the first half of the 1980s. Conflict between Iraq and Iran led to the return of the family to America.

Review of Minutes for January 17, 2010, Meeting

Friends approved the minutes as published in the newsletter.

Publications and Records Review of Guidelines for Listserv

James Harper, for Publications and Records, asked for input on guidelines for appropriate use of the listserv. Friends were in general agreement that keeping the news emails to once or twice a week is helpful, and that including events that the meeting is involved with is the primary purpose. Friends suggested that information about youth events should also be included on the listserv when appropriate. Recognizing that Meeting members often are on multiple listservs, Publications and Records takes care in including classified ads or in including requests for political advocacy or announcements of community events that are not directly associated with the Meeting or a committee of the Meeting. There was also concern that keeping the listserv going not become a full-time job for anyone. James thanked the Meeting for their input and promised to take the information back to the Publications and Records committee. He also reminded friends to keep sending ideas, concerns and suggestions to news@chapelhillfriends.org.

Hospitality Committee

Kathy Davis, for Hospitality committee, brought forward a request for input regarding having refreshments in the library at the rise of late meeting (except for potluck Sunday). Given its other responsibilities, committee members do not feel they can take on the job of of doing something more than coffee and they wondered if asking for meeting volunteers to bring in simple refreshments and be responsible for making coffee/tea once or twice a year on rotation would be possible. Someone would sign up, bring in simple refreshments, and make coffee.

Quite a few people indicated a willingness to do such a rotation, but the question also brought up questions of whether the same should be done after early meeting, and how that might affect forum.

Kathy will take feedback to committee.

Process Question around Decisions on Benevolences

Currently, the bulk of our benevolences are brought to the Meeting's attention through Peace and Social Concerns, with a few benevolences under the care of Adult Religious Education and Ministry and Worship. The Meeting was asked to think about how issues of environmental concern might be

brought to bear on our benevolences.

The clerk noted that she has communicated with the Environmental Concerns committee and asked if they wish to bring recommendations of any specific benevolences or changes to the benevolence process to Peace and Social Concerns for consideration in the upcoming year.

Friends provided feedback, including the suggestion that it is important for the full Meeting to have ample opportunity to look at the benevolences being considered, and that the various committees overseeing benevolences should work together to present information to the Meeting.

The clerk asked Ministry and Worship, Environmental Concerns and Peace and Social Concerns committees to consider the feedback and come back to the next business meeting with a process or framework for corporate discernment around benevolences.

Peace and Social Concerns: FCNL Priorities

Tom Munk, for Peace and Social Concerns, reported on our Meeting's recommendations to FCNL on priorities (attached). The individuals who met to create the priorities added a general process statement to the 5 priorities asked for by FCNL. Tom read the recommendations, and the meeting approved them. These recommendations will be forwarded to FCNL, along with a note about the number of people involved in the creation of priorities and the number of people present at business meeting where the priorities were approved (as requested by FCNL).

Peace and Social Concerns: Co-Sponsorship

Hank Elkins, for Peace and Social Concerns, asked for the Meeting to consider co-sponsoring two upcoming conferences. The first is a conference April 8-10, "Weaving a Net of Accountability: Taking on extraordinary rendition at the state and regional level," sponsored by the Duke Human Rights Center. The Meeting approved co-sponsoring this conference, leaving the question to Peace and Social Concerns as to whether they will provide any money from their budget.

The second co-sponsor opportunity is for a Speaker Series Spring 2010, "Speaking Truth – Seeking Justice in Israel-Palestine." Speakers will include Ben White, Anna Baltzer, and Mark Braverman. The series is sponsored by the

Coalition for Peace with Justice. PSC does not have in its budget the \$150 they are requesting for co-sponsorship, but recommends co-sponsorship even without monetary assistance. Friends approved becoming a co-sponsor of this conference.

Treasurer's Report

Judy Purvis, treasurer, reported that we have raised \$47,000 out of \$69,000 budgeted for the fiscal year (July – June), noting that we have gone through the fat months, so friends need to consider continuing to donate. This month the treasurer will pay 50% of all benevolences. Finance committee will recommend whether or not to pay remainder at the end of the year. Friends accepted treasurer's report (attached) with appreciation.

Announcements

- Hank Elkins reported for the Bridging the Faith Divide subcommittee from Peace and Social Concerns. They were very pleased with the recent forum and first-day school interaction with our Muslim friends. The next activity will be a forum on March 28: Duke University's Muslim chaplain and director of the Duke University Islamic Center. Nancy Milio reported that the Chapel Hill Islamic Society is interested in continuing a relationship with CHFM.
- Sue Regen from Rochester, NY, Meeting will be offering a workshop next week on "Forgiveness as a Spiritual Practice." Friday evening opening session is open to all. The full day on Saturday requires registration. We are limited to 30 at Sue's request. Sue will be joining us for a Forum next week. This workshop is the first of several that are to be funded by the bequests from Charlotte Adams and Gerry Gourley.
- The Spiritual State of the Meeting gathering will take place March 20, from 9:30am to 12:30pm.
- Jill Bolk, Executive Director of FCNL, will be in town on March 20. Meeting will take place in the afternoon, place TBD.
- FGC Summer Gathering is July 3-9. Money is available from Meeting, PFF, and from FGC (for first-timers).
- Saturday, February 27, will be HK on J (rescheduled from earlier date).

The meeting ended with silent worship.

Priority Recommendations for the Friends Committee on National Legislation

General Process Statement

The Friends Committee on National Legislation seeks to bring Quaker spiritual values and testimonies to bear on public policy decisions. The vast majority of these are short term and human centered. This ignores the growing evidence we will soon be overwhelmed by environmental changes of our making. To highlight this disparity, we divide legislative priorities into two categories. I. Longer term and II. Short term. To illuminate the connections between these two categories, we propose that longer term consequences become a routine part of short term decision analysis and recommendations. This is to help policy makers be aware of such issues as the loss of non renewable resources (e.g. petroleum); the over consumption of renewable resources (e.g. fresh water); climate change (e.g. climate extremes and rising sea level); and extinctions. The imperative is realizing the social, economic, and political implications of these changes and disappearing opportunities to soften their impact.

<u>Priority I.</u> Priority should be placed on Congress to enact measures that combat climate change. Many other countries around the world, especially in Europe, are ready and continue waiting for the US to take credible steps towards managing climate change. US involvement and leadership on multilateral environmental agreements, which can be enforced through possible penalties and sanctions, would make a much-needed statement to the world. Furthermore initiatives to foster renewable energy resources, green jobs, and much more public transportation would be very beneficial.

<u>Priority 2</u>. Acknowledge and address ongoing institutional and societal discrimination based on race, gender, class, religion, sexual orientation, and immigration status, with equal investment in every child's well-being.

<u>Priority 3</u>. Redirect military spending to constructive purposes at home and abroad. This will include retraining and pursuit of alternatives to war such as: robust diplomacy, the United Nations, multilateral problem solving, respect for international law and treaties.

<u>Priority 4</u>. Protect democracy by ending corporate control of our political system and media.

Priority 5. Implement the Universal Declaration of Human Rights in US.
