## **Eating and Entertainment for the Earth!**

"Do not wait for leaders; do it alone, person to person,"—Mother Theresa The Environmental Concerns Committee is launching a special summer film series, beginning with "UNTETHERED," a documentary by and about the Coalition to Unchain Dogs. The evening includes a delicious spaghetti supper, and the Coalition's directors will be our guests to answer questions.

The film follows the experience of Coalition volunteers as they help create a new life for Fluffy, a dog severely injured by an embedded tether, and documents the Coalition's work throughout the Triangle including the community organizing efforts that culminated in the passage of ordinances in the area that restrict the chaining of dogs. The Coalition hopes to "share information about the problems associated with tethering and how these problems impact our community," explains Amanda Arrington, Director of the Coalition to Unchain Dogs.

The Coalition to Unchain Dogs, founded in 2007, provides free fencing and installation for families with chained dogs. Most fences are constructed in just one day by a team of volunteers. All dogs receiving fences also receive a free vet appointment including vaccinations and spay/neuter.

The evening starts at 6:00pm with supper; the film itself will begin at 7:15pm. The Environmental Concerns Committee is suggesting a donation of \$10.00/adult and \$5.00/child, or whatever you can afford. The evening's proceeds will benefit the Coalition to Unchain Dogs. ## 2010 Questions and Answers for the Candidates

#### Developed by the Friends Committee on National Legislation Introduction

Much of the debate in this election season has centered on military strategies to resolve conflicts: continued fighting in Iraq and Afghanistan, bombing Iran, and expanding the "war on terrorism." You can help change the debate in this election. Challenge candidates for Congress in your area (including incumbents) to answer specific questions about how they will work to eliminate deadly weapons, conserve energy, provide health care to children in our communities, and promote diplomacy to prevent wars. Don't miss this opportunity to speak your mind!

The following questions can help you start this process. We encourage you to engage in open and constructive dialogue with the candidates for the 2008 elections. Put up a War Is Not the Answer sign at your home or in your community and write letters to the candidates. Or better yet organize a letter to the candidates from your local meeting, church, or community group. Pencil in a few events where you can meet your candidates face to face—a town hall meeting, a shopping mall meet-and-greet, or an in-home visit with a few potential supporters. Or invite the candidates to come and speak with you.

### Afghanistan: A Strategy to End the War

Congress continues to vote more money for war in Afghanistan without addressing the failure of that U.S. strategy to bring peace and security to that country and the region. President Obama has said he would begin to transfer U.S. forces out of Afghanistan in July 2011. Will you support legislation to begin a withdrawal no later than this date and to negotiate a timetable for withdrawal with the Afghan government?

FCNL's view: In 2010, the debate on Afghanistan in Congress tends to break down between "out now" and "keep fighting." The debate in Congress should be about the strategy that will end the fighting, bring U.S. troops home, and support efforts by the Afghan people to rebuild their country. #### Time to Invest in Peace

In 2009, 33% of my tax dollars went to the military. Just 1% was spent on tools to help prevent war: diplomacy, development, and international cooperation. The U.S. needs civilian experts and readily available funds to help prevent, not just fight, wars. Will you support fully funding the State Department's new Civilian Response Corps, as well as the President's \$100 million request for a Complex Crises Fund to help prevent crises?

FCNL's view: FCNL's view: President Obama, Secretary of Defense Gates, and bipartisan congressional leaders agree that the United States needs more than just military might to build security in today's world. Congress has yet to invest adequately in the civilian tools of diplomacy, development, and international cooperation. For example, the Civilian Response Corps—a new corps of experts from civilian agencies who can help prevent and rebuild after warscontinues to be underfunded. #### Broken Bookkeeping - Time to Audit the Pentagon

Every major federal agency, except the Pentagon, is required to account for what it spends each year. The Pentagon has acknowledged that its financial books do not conform to accounting standards. Will you publicly endorse the call for the Pentagon to be subject to annual audits and support legislation that would require the Pentagon's books to be audited?

FCNL's view: As Defense Industry Daily noted in 2009, "It's not that the US Department of Defense fails audits. The problem is more fundamental: it is not currently possible to audit it, and any comprehensive audit would be a first-ever event in modern times." The Pentagon spent 33 cents of every tax dollar you paid in 2009. It should be required to account for that money like everyone else. #### Fix the Broken Immigration System

The U.S. immigration system is broken. For more than 15 years, Congress has failed to pass comprehensive legislation to reform the system. If you are elected, will you cosponsor or endorse Rep. Luis Gutierrez's legislation (H.R. 4321) that promotes family unity, brings undocumented immigrants out of the shadows, and upholds immigrants' human and civil rights?

FCNL's view: Few people dispute that the U.S. immigration system is broken and inhumane, but many of the solutions offered focus on tighter controls on the border and more law enforcement rather than changing the current system. Instead of focusing on law enforcement, Congress should focus on fixing the broken immigration system to meet the needs of the United States in the 21st century. #### Reduce Risk of Nuclear Weapons

Do you support the call from former Secretaries of State Henry Kissinger and George Shultz, former Sen. Sam Nunn, and former Defense Secretary William Perry for the United States to make a priority of pursuing "a world free of nuclear weapons?" If you are in the Senate when the new START treaty with Russia and the Comprehensive Test Ban Treaty (CTBT) are brought to a vote, will you vote for ratification?

FCNL's view: For the first time in decades, leading opinion makers in both major political parties recognize the nuclear weapons don't assure U.S. security. In the next two years, the Senate will have an opportunity to ratify the new START treaty with Russia and the CTBT. Ratification requires 67 votes. #### Cut Greenhouse Gas Pollution

Global warming threatens the survival of the planet as we know it. Working together, the United States and other nations have the resources to address global warming by creating a new green global economy. Will you cosponsor bipartisan legislation introduced by Senators Maria Cantwell and Susan Collins that would provide simple, fair and effective means to reduce greenhouse gas pollution, or support similar legislation in the House?

FCNL's view: If the international community does not act now to mitigate global warming and dramatically diminish the human contribution to it, the human species could face catastrophic global change that would affect all life on Earth. The cap and trade legislation passed by the House in 2009 and similar legislation debated in the Senate did not take us in the right direction. The CLEAR Act (S. 2877) is the kind of legislation that should. Find details at <a href="https://www.fcnl.org/q&a2010">www.fcnl.org/q&a2010</a>.

#### Honor the Promises for Native Americans

Indian Country is experiencing a public safety crisis. Will you cosponsor or endorse the Tribal Law and Order Act (S. 797 and H.R. 1924) to increase communication and cooperation between federal, state, local and tribal authorities; increase funding, training and authority of tribal governments and law enforcement agencies; and take steps to reduce violent crime and violence against women?

FCNL's view: Native Americans are addressing problems on Indian reservations. Yet a deficient justice system, insufficient funding and support from the federal government, and high crime rates and high rates of domestic and sexual violence are factors which contribute to a sense of lawlessness on some reservations. # Chapel Hill Friends Meeting Meeting for Worship with Attention to Business April 18, 2010

Jennifer Leeman, clerk, opened the meeting with the query: When disagreements arise, are they recognized, discussed, and resolved with loving patience and forbearance?

#### Welcome

We welcomed newcomer Israel Williams.

#### Approval of March 2010 minutes

Friends approved the minutes of the March 21st Meeting for Worship with Attention to Business as printed in the newsletter.

#### **Nominating Committee**

Jeff Brown, clerk of the Nominating Committee, reported on the worshipful process used to discern nominations for the position of clerk of the meeting.

In addition to the Nominating Committee, Lynn Drake and Marilyn Dyer from Care & Counsel and Pat Mann, Jennifer Leeman and Alice Carlton from Ministry & Worship were involved. The committee is pleased to recommend Carolyn White as the next clerk of the meeting. Her name will be held over for approval until next month, as is our practice. Anyone with comments or questions should forward them to Jeff Brown.

The Nominating Committee also recommended appointing Terry Mehlman as the Meeting's representative to Friends for Lesbian, Gay, Bisexual, Transgender, and Queer Concerns. The meeting approved. The clerk will write a travelling minute for Terry to carry with her when she attends FLGBTQC meetings.

#### Recommendation of Micheal Jokinen for Membership

Alice Carlton, for Ministry & Worship, read a short note of introduction for Micheal Jokinen (attached) and reported that after several meetings with Michael, the committee joyfully recommends him for membership. The meeting approved.

A welcoming party will be convened by Alice Carlton, assisted by Robin Harper.

#### Treasurer's Report

Judy Purvis, treasurer, reported that with three months left in the fiscal year we have raised approximately 56,000, but have about 13,000 to go. Friends accepted the report (attached).

#### **Finance Committee**

Terry Mehlman, clerk of the Finance Committee, reported that several committees are overspending their budgets for the year, or are on track to overspend by the end of the year. Finance Committee is considering creating a policy for handling committee overspending, and asks for feedback from the meeting.

#### **Benevolence Planning**

Tom Munk, for Peace & Social Concerns, gave an update on the process of planning for the Meeting's benevolences. Two months ago, the Meeting for

Business raised the question of whether we wanted to focus benevolences more on environmental concerns and asked Peace & Social Concerns, Environmental Concerns, and Ministry and Worship to discuss the issue. The group hopes to bring a recommended list of benevolences to the evening business meeting on May 6. The hope is not to increase the amount of money going towards benevolences, but to increase the percentage of this amount that goes towards environmental concerns.

#### Carolina Friends School Board Update

Nancy Milio, a meeting-appointed board member at CFS, reported that the CFS board has approved new bylaws. The primary purpose of the renewal of the bylaws is to allow the board to draw on a more diverse community of resources to position the school to continue to excel and to raise its profile within the community and nationally.

The meeting will receive a full copy, but the primary effect of the changes on the meeting is that now CHFM and Durham meeting will each have only 4 board members, rather than 7. The CFS board size will remain at 23, with 8 nominated by the two meetings instead of 14. Nancy explained that the school had been using the Quaker majority on the board to qualify as a Quaker school for membership in the Friends Council on Education. The change in bylaws will eliminate the guaranteed Quaker majority, but the school will assure the continuation of its Quaker character through seeking accreditation through Friends Council on Education.

Because three of the Chapel Hill Meeting's 7 board members are finishing terms this year, the Meeting will not be nominating any new board members to start in fall 2010. Next year, the CFS Governance Committee will meet with the Meeting's nominating committee to consider the timing of nominations, since CFS needs to know who might be nominated to the board much earlier than the meeting's normal nomination cycle.

One Friend asked whether the meeting would be limited to only 4 board members. It was clarified that the four board members nominated by the Meeting would have the responsibility to bring concerns to and from the Meeting and the School, but that would not stop other members or attenders of the meeting from being asked by the board to serve.

- The meeting will hold an evening Meeting for Worship with Attention to Business on May 6. The primary topic will be to consider benevolences.

- The group of Muslims looking for a place to start a new mosque and cultural center in Chapel Hill is considering meeting at Chapel Hill Friends Meeting until they can find a place of their own.
- Rick Edens of the Chapel Hill United Church of Christ is trying to revitalize the Chapel Hill Clergy Coalition. Alice Carlton will be attending the first meeting on Earth Day. If the group flourishes, we may want eventually to have an official representative.
- The Orange County Dispute Settlement Center is looking for board members.
- Building and Grounds has approved allowing the Environmental Concerns
  Committee to sponsor a spaghetti and film fund raising effort. The first event
  will take place on May 22 and will raise money for the Coalition to Unchain
  Dogs.

#### Micheal Jokinen Biosketch

Micheal Jokinen was born and raised in a remote iron mining area in far northern Minnesota, about 60 miles south of the Canadian border. He spent much of his childhood "out in the woods" as they said up there and developed a deep love for and spiritual connection to the natural world, something that continues to be a major part of his spiritual life.

He graduated from the University of Minnesota in 1968 with a degree in electrical engineering and later attended veterinary school at the University of Minnesota and graduated with a Doctor of Veterinary Medicine degree in 1976. After two years in practice he decided to specialize in veterinary pathology and in 1983 he got a position in veterinary pathology here in North Carolina.

His life experienced a profound change in 2003 when he married Ruth Hamilton and she introduced him to Quakerism. He had never found a faith organization that he desired to join but after attending Meeting here in Chapel Hill he realized he had found a faith community that he wanted to be part of, and after attending Meeting here for six years he applied for membership.

Another profound change occurred when Micheal and Ruth honeymooned in New Mexico. They both came totally enthralled with the Land of Enchantment where they eventually bought some land and built a small house, and where they now spend part of the year. Micheal and Ruth find New Mexico to be a deeply spiritual place for them and it appeals very strongly to Micheal's spiritual connection to the natural world. Eventually they hope to live there full time.

Micheal feels he has been truly blessed in his life, and for this he is deeply grateful.

### Bridging the Faith Divide Ad Hoc Subcommittee Report to Meeting – Sunday, April 18, 2010

The committee continues to sponsor forums and nurture our contacts with our American Muslim brothers and sisters in a way that is developing deeper connections and overlapping goals. Imam Abdullah Antepli's forum (Listening to our Muslim Neighbors) on March 28 was well received and prompted many messages in meeting for worship afterwards. CFS and the Afghan Sister School Project will be presented on May 2. This links the work of our committee, CFS, and Peace & Social Concerns.

In our outreach, we have widened our relationships with local Muslims and extended those already made to go beyond superficial acquaintances. Kay Eager is arranging a visit to Jammat Ibad Ar-Rahman in Durham with Imam Amr. We have been invited by a local group of Muslims to give input in their efforts to form a more progressive mosque and cultural center in the area. Our meeting was invited to attend a "Girls Youth from Durham Mosque" potluck at CFS on April 17. Bettie Flash, Nancy Milio, Ann Shy, and Marsha Green all attended and were welcomed warmly. Also continuing is our related work with TIMELEAP (Triangle Interfaith Middle East Legislative and Advocacy Project) as it develops an interfaith spiritual leaders group to address the crises in the Middle East.

The subcommittee is grateful for the support, encouragement, and involvement of the entire meeting as we build these bridges of understanding and compassion.
