Holiday Meals

During the winter holiday season, please consider sharing a meal with someone who might not otherwise get one. A gift of only \$25 helps the IFC offer a family a holiday meal--a turkey or ham, mashed potatoes, stuffing, vegetables, bread and dessert.

Each year, the IFC provides holiday meals to almost 1,000 families, an effort which requires community collaboration. With help from local congregations and community volunteers, bags of non-perishable food items (e.g., instant potatoes, gravy mix, canned vegetables) are assembled in advance. As the clients arrive to pick up their meals, frozen turkeys or hams and other perishable food (e.g., dinner rolls and pies) are added. In recent years, fresh produce has been included in the bags thanks to a special collaboration with Farmer Foodshare. Special arrangements are made to provide meals to shut-ins. On the evening of the last distribution day, people who did not sign up in time can come and see if there is any extra food, which is distributed on a first-come, first-served basis.

The holiday season is one of the happiest times of the year at the IFC and these meals make a huge difference in the lives of people right here in our local community. If you would like to help, please send your check made out to the IFC for \$25 to:

Chapel Hill Monthly Meeting of the Religious Society of Friends Meeting for Worship with Attention to Business Minutes October 20, 2013 Tom Munk, clerk; Robin Harper, recording clerk

Worship and query: How do we help our members and attenders to discover and develop their spiritual gifts? How do we assist visitors, attenders, and members to grow in their ability to participate in silent worship?

Friends spoke about the need to educate new Friends, to let slip away what does not speak to us in verbal messages, and to learn ways to cultivate meaningful silence.

- **1. Welcome, recognition of first time attenders, review of agenda** There were no first time attenders.
- 2. Review of minutes for September Meeting for Worship with Attention to Business Approved.

3. Membership request: Buffie Webber-Tom

Tom read Buffie's request for a clearness committee for membership. Her request will be conveyed to M&W to form a committee.

4. Naming Committee-Tom

Since Nominations does not nominate its own members, a few Friends are needed to name new Nominations Committee members. Names will be submitted in November, held over, and approved in December. It's not known which members of the committee may be rotating off, but the roster does need to be reconsidered, as not all members have been able to serve actively. It's important that the Naming Committee members know the Meeting well, to be able to make good recommendations. Jennifer Leeman and Allie Scales agreed to nominate members for the 2014 Nominations Committee.

5. Meeting Directory-James Harper

The Publications and Records Committee proposes the following change to the Directory production schedule: Publications and Records would like to change the printing date of the Meeting Directory. Currently, directories are printed for January. Printing them in the summer would coincide with the Meeting's fiscal year and the start of new committee memberships. It would also be easier on the Publications committee not to work on the Directory during the holiday season. If this change is approved, Publications and Records will still collect updates and make phone calls for a temporary 2014 directory. This temporary directory will be available electronically in January; Friends can print it themselves. Those without computer access can request a paper printout from Publications and Records. Then, in July, additional updates will be made and it will be printed in booklet form for July 2014–June 2015.

Finance Committee clerk Matt Drake noted that having a more updated directory at the beginning of fiscal year would help his committee as well.

The Meeting approved making this change.

James also requested volunteers to help with calling people in the directory, to update their contact information. Kathleen McNeil, Kitty Bergel, Carolyn Stuart, Asta Crowe, Marilyn Dyer, and Jeff Brown agreed to help with this task.

6. Finance Committee Annual Report—Matt Drake (Attached)

After Matt gave his report, he answered several Friends' questions: We do still have accounts at Friends Fiduciary, which is a national Friends organization in Philadelphia that manages Friends' investments. CHFM is also still accepting donations of stock from its members and attenders. In reference to our estimated property value of \$1.5 million, one Friend asked if we are insured for that amount. We do have liability and disaster insurance, but Matt will check on the exact amount. As to the security of Finance Committee documents, such as our letters of incorporation, Matt noted that copies of all documents are kept in the Finance Committee file cabinet drawer, and are backed up on our webpage.

Great appreciation was expressed for our Finance Committee, and their report was accepted with thanks.

7. Treasurer's Report on First Quarter of Fiscal Year-Matt Drake (Attached)

Matt answered questions after presenting the report, one of which was about the approximately \$5000 each that the Meeting brings in from building rental and football parking. He reminded us that the money from building rental goes directly into meetinghouse upkeep, and that the Meeting youth get the first use of the money from football parking, after UBIT (Unrelated Business Income Tax) is paid. Anything left after that goes into our checking account, and supplies a bit of cushion if we don't quite meet our budget. Another Friend asked about the money for the new chairs, which Matt said came directly from the budget of Buildings & Grounds, but could have come from the rental income if needed.

The report was accepted with gratitude to the Finance Committee.

FINANCE COMMITTEE ANNUAL REPORT, OCTOBER 20, 2013

On June 22, 2012 the NC Secretary of State Office approved our application for incorporation as a non-profit corporation. This was announced at the August 19, 2012 Meeting for Worship with Attention to Business (MWAB). Our legal name is now Chapel Hill Friends Meeting Incorporated. Our incorporation *#* is C201217200111. The original copy, along with the application form, was given to the Clerk for the Meeting's records, and two copies were placed in Finance Committee files.

On February 25, 2013, Judy Purvis, Treasurer, reported to Finance that the transfer of accounts from Bank of America to BB&T had been completed. We now have three accounts at BB&T: Checking, Overdraft Savings, and Meetinghouse Renovations Savings.

In the spring of 2013 we worked with the Care and Counsel Committee on procedures to accomplish the Meeting's decision to support Pam Schwingl in her leading to provide financial support for Annie DiLorenzo. Result: Friends can give gifts restricted to the C&C Committee.

In June 2013 Judy Purvis completed her service as Meeting Treasurer, and MWAB approved Maura Murphy as the new Treasurer. Judy provided a wonderful service to the Meeting as Treasurer. She and the committee worked well together. Judy was extremely helpful in the change-over of Treasurers, leaving clear records as well as explanatory notes about how she had fulfilled her duties. We are grateful for the Nominations Committee's recommendation of Maura as the new Treasurer, appreciate the knowledge and experience she brings, and look forward to working with her.

On June 24, 2013 the Committee approved the CALENDAR OF ACTIVITIES FOR THE FINANCE COMMITTEE AND THE TREASURER THROUGHOUT A FISCAL YEAR, JULY 1 – JUNE 30. This two-year project resulted in a five page, monthly "to do" list of duties and deadlines to guide us in helping the Meeting achieve its goals and be a good steward of its resources. A list of Meeting policy decisions related to income and expenses conclude the CALENDAR. This is a "living document" that will be referred to monthly and reviewed and updated as needed by Finance.

June 30, 2013: contributions by Friends surpassed the 2012–13 budget goal, for which we are very grateful. We started explaining the budget in September, encouraged Friends to send us their giving plans for the fiscal year early in the fall, invited contributions by email and mail, followed by personal contacts in October and November, and reminded not-yet-giving Friends in December. We thanked Friends for their giving plans and contributions. At the end of January 2013 we emailed/mailed contributors the IRS recommended receipt statements for their 2012 calendar year contributions. In the spring we updated Friends who had given us their giving plans on their contributions to date.

Note: Contributing individuals and families continue to number in the 100 to 110 range. Contribution amounts range from a few dollars in cash to over \$2,000 in regular payments. We did not conduct a spring 2013 end-of-fiscal year fundraising campaign because it was clear to us by that time that contributions were going to at least match the 2012-13 budget total.

We continued to work with committee clerks by participating in the fall Clerks Workshop, updated clerks on expenditures as needed, informed them in February or March about the amounts remaining in their current budgets, and invited their budget requests for the next fiscal year in March and April. In May we presented these and other requests to MWAB in a proposed budget and revised it as requested for MWAB's decision in June. The 2013–14 fiscal year began July 1, 2013.

The Treasurer continued to report year-to-date budget, income, and expenditure amounts to MWAB in October, January, March, and June. We plan for the Treasurer to present the end-of-2012-13 fiscal year report to the September MWAB.

The value of our property increased this year, due to the 350 sq. ft. addition to the school house by Carolina Friends School. CFS expanded the teachers' office and built a storeroom for use by the Chapel Hill Early School teachers. The project cost about \$80,000, was funded by contributions to the CFS Building Friends capital campaign, and was completed in time for the start of school in fall 2012.

For your information, the Meeting, as a non-profit corporation, does not pay property tax. (FYI: Finance received notice on April 18, 2013 from the Orange County Tax Office that the 2013 Market Value and Assessed Value of our property is \$1,450,300.) We do, however, pay an Orange County Water and Sewer Tax and an Orange County Chapel Hill Stormwater Drainage fee. Carolina Friends School reimburses us for one-half of these costs.

This year we look forward to encouraging Friends to contribute to the Meeting by arranging payments through their bank or credit union and to consider including the Meeting in their wills. We encourage P&SC Committee to make its benevolence recommendations after mid–January, by which time Finance will have a good idea of the likely total of contributions by June 30. Also, we look forward to working with the B&G Committee as it moves closer to planning the upcoming meetinghouse renovations.

Finance Committee members: At our February 25, 2013 meeting we received Brian Stuhlmuller's resignation from the committee and shared our appreciation for his valuable service to our committee. In July we welcomed Loren Hintz to the committee. Current members are: Kitty Bergel, David Brower, Bob Durovich, Matt Drake (clerk), Loren Hintz, Tom Ludlow, Ann Miller, and Maura Murphy (Treasurer).

Francis Coyle has always known that service is simply a basic staple of daily living. He grew up in a Roman Catholic household where a subscription to "The Catholic Worker" newspaper, started in the Depression by social activist, Dorothy Day, infused his family's life and spiritual practice with its guiding tenet of the God-given dignity of every human being.

He and wife, Marguerite, met on a farm near Cincinnati in the late 1940s in a Catholic Worker summer program where he had an internship. They married in 1953, and have nine children. Francis found that the authoritarianism of Catholicism chaffing. It irked his spiritual inner footing to have "guys trying to explain things" and the steps to take.

Francis was teaching at Asheville Biltmore College (now UNC-Asheville) in 1972 when he was tapped to be the local Chairman for the McGovern campaign in the area. He stumbled upon Friends Meeting, for members of the Meeting were volunteering for the McGovern campaign. Francis was quite taken by their "peaceable-ness to the aggressive hostile environment" surrounding the campaign. "They were friendly." The Quaker belief of "immediate communication with a higher power rang true," and he began attending. He has been a Friend ever since.

Francis came to Chapel Hill Friends Meeting in 1979, when he and Marguerite and their family moved from Asheville to accept a Computer Programming position at Duke University, from which he retired in 1996. Then he went right back into the whirl of computers at Senior Net, a volunteer organization to teach seniors how to use these new-fangled gizmos.

He served for many years as Treasurer of Chapel Hill Friends Meeting and is the longtime Convener of Interfaith Council Committee. Lois Ann Hobbs, a Trustee of Chapel Hill Friends Meeting noted that "Francis is a loyal member of the meeting—of the back-seat way—always dependable, always a worker."

He and Marguerite also have been as well known for getting into trouble. Recently they kept faith with their long-established record of activist-inspired arrests, when both were arrested at a Moral Monday demonstration. Marguerite's commitment to social justice matches that of Francis's: she belongs to the Women's International League for Peace and Freedom, as well as the Raging Grannies. The couple has demonstrated, and been arrested, during a pray-in protest at the air force base in Goldsboro and famously at the School for the Americas, located on Fort Benning military base in Georgia. Characterized by Francis as a "second home" for it was the site of his recruit training upon his being drafted in the Spring of 1945, luckily after the Germans had surrendered; soon to be followed by the August surrender by Japan.

After his military service, Francis had training and a Tech Ag career. But due to a growing allergy to dust found on farms, Francis switched into Math and Physics, getting his BS at the University of Georgia in 1956, Phi Beta Kappa, Cum Laude followed by a MS in Physics in 1961.

Friend Francis has served with grace and fine-honed sensibilities to the betterment of the people and spiritual homes in the communities in which he and Marguerite have volunteered their time and efforts in commitment to their leadings.
