Dr. Sheldon Lanier, Ed.D, Director of Equity Leadership/AVID for CHCCS will present "**The Black Image in the White Mind: Educational Consequences of Media Racism.**" This conversation will explore racial stereotypes of African American males in the media and how these stereotypes impact the treatment and academic achievement of students of color. This session will also provide an analysis of the historical and structural practices that have allowed institutional racism in the media to flourish.

A prayer of hope and perseverance from Michael Eric Dyson's book *Tears We Cannot Stop*. [Curt Torrell read this during Meeting for Worship on Nov. 26]

Oh God, the hour is dark. The suffering great. But we will not give up. We will not surrender. We will not surrender because we have endured the last of spite and the whip of hate on our backs. We will not surrender because our mothers and fathers, and their mothers and fathers, and their mothers and fathers, and their mothers and fathers, too, believed in you, believed in us, believed that no obstacle put in their way could stop them. They believed that grace you gave them for their journeys would outlast any challenge in their hearts and minds. We will not surrender because your enduring and indestructible Word feeds the souls of our people. We will not surrender because blackness is a gift that has blessed the world beyond compare. Our minds and hearts, and our tongues and bodies, too, have made Earth a better place to live. We will not surrender because we have survived. Oh God, we are not naive. We know, just as white American knows, that our legion, multiple, complicated, adaptable, triumphant blackness threatens whiteness. Oh God, you placed a paradox in our midst like a rainbow at the end of a storm: if we are to understand America we must understand blackness. Oh Lord, black folk are everything; we are every possibility of American, even human, identity made real. That means we are everywhere, just like our white brothers and sisters. We are going nowhere. We are your children too. We will survive. We are America.

On behalf of Quaker House, we remind everyone that the North Carolina Commission of Inquiry on Torture (NCCIT), an independent non-profit and non-governmental commission, will be conducting public hearings on NC's role in our state and federal program of torture. These hearings are free and open to the public and will be held at the Raleigh Convention Center, 500 S. Salisbury St., Raleigh, on Thursday, Nov. 30 from 9am - 5pm and Friday, Dec. 1 from 9am - 3pm. 1. We opened with worship and the query: "Do I contribute generously within my means to the funding of the Meeting?" Friends spoke to how much they value our meeting community and how it supports us as we go out to act in the world. Friends also spoke to how they are discerning what they will give to the meeting and to other organizations. Friends recognized the work our youth do this time of year to select the organizations they will support through the alternative gift mart and also the work of our Meeting's Benevolence Subcommittee, which is discerning this year's benevolences. We often feel ambivalent about money, particularly its use by our government in ways that are counter to our beliefs and values. Friends appreciated the opportunity to think about the positive power of money to do good in the world.

2. We recognized three first time attenders, to Meeting for Worship with Attention to Business (MWAB): Lori Fernald Khamala, Joyce Johnson, Camille Berry
3. Minutes of the October 15, 2017 MWAB were reviewed. **The October 15, 2017 minutes were accepted as written.**
4. Matt Drake, Clerk, recommended David Curtin and Bonnie Raphael to serve as the Naming Committee. The Naming Committee serves a roughly two month term for the purpose of recommending Friends to join the Nominations Committee. **We approved David Curtin and Bonnie Raphael to serve as the Naming Committee.**
5. Dottie Heninger, Nominations Committee member, recommended Ronald Carnes and Hongmin Ahn for the Hospitality Committee. **We approved Ronald Carnes and Hongmin Ahn to serve on the Hospitality Committee.**
6. Jan Hutton, Clerk of the Mary & Claude Shotts/Leadership Development Fund, read the committee's annual report (attached). Friends expressed gratitude for the work the committee has done to increase the number receiving funds to attend educational/enrichment opportunities. Friends also noted that this success is coupled with a reduction in the amount of money in the fund. The funds are not needs based and all may apply. The committee is wrestling with how to continue to be generous in supporting Friends. Friends asked whether 10% of money left to the Meeting in wills is still being donated to the fund. Research will be needed to answer the question. **We accepted the annual report of the Mary & Claude Shotts/Leadership Development Fund with gratitude.**
7. Matt Drake, Clerk, read a letter from Lori Fernald Khamala and Sean Chen asking to be married under the care of the Meeting (attached). **The letter was referred to the Care and Counsel Committee to create a marriage clearness committee.**
8. Matt Drake, Clerk, read a letter from Sean Chen, Tallulah Chen, and Matilda Chen asking to join the Meeting, Sean and Tallulah as members and Matilda as a familial member (attached). A question was raised about teens joining the Meeting. A taskforce of Ministry & Worship has been exploring how the Meeting handles familial members, and they are strongly in support of teens becoming members prior to their heading into the wider world. **The letter was referred to the Ministry and Worship Committee to create clearness for membership committees.**
9. Don Hopper, Clerk of Building and Grounds Committee, provided an update on the renovations of the lower level of the meetinghouse. January is the anticipated completion date. The sheetrock is complete and almost all cabinets are installed. The painters arrive tomorrow. Friends expressed appreciation for Don and the Building and Grounds Committee's work.
10. Alice Carlton, Ministry and Worship Committee member, read a report of the Spiritual State of the Meeting meeting that was held on October 21, 2017 (attached). An amendment to the report was agreed to, noting that our Meeting also includes members of the Jewish and Muslim faiths and non-theists. **The report was approved as amended and will be sent to Piedmont Friends Yearly Meeting.**
11. Joanna Selim, Hospitality Committee Co-Clerk, presented a request that Meeting committees assist Hospitality by providing a "greeter" on a regular basis for the 11:00 AM Meeting for Worship. **Matt will circulate Hospitality's request to committee clerks.**
The Committee also requested suggestions from the Meeting community for refreshing the entrance (foyer) to the meetinghouse to enhance the feeling of the space to be more welcoming. Ideas generated within Hospitality committee include having live plants, consolidating the paper notices, removing one of the tables, putting a colorful "Welcome" sign on the wall (perhaps made by the First Day School), replacing the name tag tapestry, and improving the lighting. 12. Carolyn Stuart, Co-Clerk of Children and Youth Religious Education Committee, invited all to attend the Meeting Christmas Party on December 10, 5:00 PM in the schoolhouse. Friends are asked to bring finger foods. There will be

13. Matt Drake, Clerk, reported on two letters received. Matt is passing the letter on to Peace & Justice Committee. Matt also received a letter from the Steering Committee of Southern Appalachian Young Friends (SAYF) inviting adults to serve as "FANS" (Friendly Adults Nurturers) at Young Friends retreats. He is passing the letter on to Children and Youth Religious Education Committee. Sean is currently a FAN and Tom Munk has been previously. Both spoke to the value of serving as a FAN as a spiritual experience and an opportunity to see the powerful community the youth create for themselves. Tallulah Chen is co-clerk of SAYF.

Shotts Memorial and Leadership Development Fund Committee Annual Report, 2016-2017

The Mary and Claude Shotts/Leadership Development committee oversees two funds to support the leadings of Friends, both members and attenders, to enrich and deepen their capacity for leadership within the Meeting, the local community, and the Religious Society of Friends.

The Mary and Claude Shotts Memorial Fund, established in 1973 from funds donated by members of the Shotts family, provides financial support to enrich and develop the lives of individuals with a relationship to the Chapel Hill Friends Meeting. Grants from this fund are distributed from the interest earned on principal.

The Leadership Development Fund, established in 1982, provides grants to benefit the spiritual life of the Meeting through the enhancement of leadership capabilities in individuals. Grants from this fund are distributed from money carried over from prior years and from annual allocations approved by the monthly meeting.

Friends Fiduciary manages the investments for the Shotts Memorial Fund, and our current balance is \$33,768.20.. From this fund, we receive approximately \$1200 total, in interest, divided between June and December, to give out each year as disbursements. Our current funds' balance in our BB&T account is \$2962.66.

Because of concerns about supporting a common awareness that the support of the Shotts/Leadership funds is not "need based", the Committee made additional efforts to communicate information about the funds through the newsletter, listserv, speaking with individual Friends, and a Forum. We are happy to report that this resulted in a considerable number of Friends receiving support during the 2016-2017 FY, as noted below.

Seawall and Jamie Jacobs for participation in a Racial Equity Training, Phase 1; Maura Murphy, Carolyn White, in their roles of service on various CHFM committees, to attend a ServantKeeper software workshop; ten members and attenders supported in their attendance at the PFF/PFYM March annual retreat; Emma Hulbert, Phoebe Hulbert, and Evangeline Rioux participated in the FCNL Teen Lobbying weekend in Washington DC; Catherine Alguire and Wendy Michener attended the 2017 FGC Gathering in Niagara Falls, NY; Claire Bates attended the Ben Lomond Center for a program entitled, "The applicability of the Friend's tradition in working on social change today."; supported two teens in their attendance at the SAYMA June annual retreat.

Our total disbursements for the 2016 - 2017 fiscal year were \$4,537. We were left with a balance of approximately \$500 and requested \$2000 from CHFM, to be included in the 2017- 2018 budget; this was approved.

Spiritual State of the Meeting summary report

Friends gathered on Saturday, October 21, 2017, to consider the spiritual state of the Chapel Hill Friends Meeting. This report is a reflection of the sharings on these queries:

1) What brings you to the Chapel Hill Friends Meeting? What were you hoping for? How have our Worship/Committees/Programming nurtured you:

**spiritual life *social witness *gifts *family*

2) What do you appreciate about our Meeting? What challenges do you believe we face as a Quaker community?

3) What do we want to share and learn from other Meetings in Piedmont Friends Yearly Meeting?

Friends in the Chapel Hill Friends Meeting come from many different backgrounds: Baptist, Catholic, Jewish, Muslim, Non-Theist, Presbyterian, Unitarian, programmed Friends Churches, or other unprogrammed Meetings. Some come with a partner, some come when attending school at UNC. All are seeking a place to deepen their spiritual lives, quiet the noise from the world, and share in community. They have found a place where they can discover their gifts and

have them nurtured, a place they can bring their children knowing they will be loved and valued. Sitting in silence can be transformational. As one Friend said, "I am a changed person because of the Meeting."

Appreciation for our Meeting runs deep and wide. Some are looking for a venue for social activism. Some value the activism of others even if it is not their own leading at this time. There is much appreciation for the guests from Orange Correctional Center (OCC) who enrich our community in many ways, especially through their participation in Meetings for Worship. Some find the early worship with greater silence and less vocal ministry especially appealing. Older Friends who struggle with hearing loss find the efforts to address this issue with our new sound amplification system helpful. We all have different abilities and leadings. Many express gratitude that we are not told what we have to do and believe. The diversity of beliefs is a strength. Others come for renewal and don't want to be drained by too many announcements and too much focus on social action. Yet many feel kinship with the kindred spirits they find in Meeting. It is family.

One challenge we face is how to encourage spiritual connections on Sunday mornings that go beyond superficial greetings. Small groups like committees, interest groups, and clearness committees can help with this. Many in Chapel Hill Meeting are grey haired. How do we support and develop the community of young people? When we need to spend money to renovate our building, differing opinions can be difficult to manage. How can we make these decisions in love for one another and not leave unresolved feelings? Chatter in the library and foyer can disturb those settling in for worship. How can we ease the transition from visiting as we arrive and move into silent worship? How can we keep the Meeting room at a comfortable temperature and make it a pleasant and uplifting space? Some people feel we work ourselves too hard. How can we support good self-care? How do we balance the focus on the world with the need for a safe haven? A big challenge is how to relate to our fractured world, how to reach across the divide to others with differing views, how to connect our faith to practice. There is talk of having a retreat to address our rage/grief about the current political situation. Would Piedmont Friends Yearly Meeting be a place for this to happen?

We recognize the importance of our membership in Piedmont Friends Fellowship and Yearly Meeting. We wonder what other Meetings are doing to build community, to have deeper relations. How do we encourage more Friends to attend PFF/YM? Can we organize car pools, have worship on Sundays with PFF/YM rather than at CHFM? We also wonder how other Meetings embrace their faith and put it into practice. Through the Concerned Friends program, we want to respond to social concerns of interest and coordinate our efforts with other Meetings. PFYM may create opportunities for committee clerks to get together to talk/brainstorm/compare notes, etc. We would like to share what we have done and hear what other Meetings are doing. We look forward to deepening our connections with each other in PFF/YM.
