Rep. Butterfield co-sponsors resolution to repeal the 2001 Authorization for the Use of Military Force

Three days after 9/11, Congress gave the president advance permission to use military force against anyone who planned, authorized, committed, or aided those attacks, or who harbored such groups. This is the 2001 Authorization for the Use of Military Force (AUMF) In theory, that only should have applied to the Taliban and al-Qaeda in Afghanistan. But later, the Bush administration developed the concept of "associated forces" – which three administrations have now used to expand the war to more than half a dozen groups around the world.

On May 30, Hart Pillow led an advocacy team to the Durham office of Representative Butterfield, asking that he cosign HR 1274, to end the 2001 Authorization for the Use of Military Force. **He agreed to do so!** And his foreign policy staffer said he thought Rep. Clayton would follow suit.

On Friday, June 7, at 2:30, Tom Munk will lead another team to make the same request of David Price. They will be thanking him for voting (in committee) to attach HR 1274 to the military appropriations bill and asking that he go one step further and co-sponsor it.

1. Opening worship and query – Matt Drake, Meeting Clerk. Query: "How does participation in Meeting for Worship contribute to my life-long spiritual journey?"

2. Welcome, recognition of first time attender, Don Pinnix, review of agenda.

3. Minutes of the April 18, 2019 Meeting for Worship with Attention to Business (MWAB) were approved as written.

4. Carolyn Stuart, Clerk of IFC Committee, presented the Interfaith Council (IFC) Annual Report. A Friend added that IFC has met its fund-raising goal to build the new building at 110 W. Main Street, Carrboro. Meeting volunteers continue to serve lunch for the first Thursday noon meal for an average of 50-80 people. A Friend raised the question of the identities of the seven women who founded the IFC. Four names, including three from our meeting, have been found. We accepted the report with appreciation. (Appendix 1).

5. Don Hopper, Clerk, Building and Grounds Committee, gave an update on the renovations of the meeting room. The ceiling support beams have been installed. The lights have been reinstalled as has the installation of the HVAC system. Inspections have been passed. Installation of sheet rock and acoustical ceiling tiles has been scheduled. Next will be painting the walls and molding. Installation of the new floor will follow. Outside porch lights will be updated. Panic bars must be added to the doors according to Town codes. Estimated completion will be the end of June. We accepted his report with deep gratitude.

6. Dottie Heninger, Co-clerk, Nominations Committee, presented their annual report. It was accepted with appreciation. She then presented a handout of the proposed nominations for Meeting officers, committees and appointees, starting July 1, 2019. Nominations recommended Chris Stanley for consideration as clerk of the meeting (Appendix 2). Final approval of the nominations will be made at the June MWAB.

Concerns were raised that the ad hoc clerk search committee had not contacted Ministry and Worship and Care and Counsel Committees directly to suggest names for that committee and for the Clerk of Meeting. That process was not followed this year. With that concern came strong support for the Friend nominated for Clerk of Meeting position.

7. Jan Hutton, Clerk, Ministry and Worship Committee (M&W), presented recommended benevolences under the care of M&W for 2018-2019 totaling \$1400. We approved the recommended benevolences: \$600 for Friends General Conference (FGC), \$150 for Friends Journal (with \$50 of that designated for QuakerSpeak), \$350 for Piedmont Friends Fellowship/Piedmont Friends Yearly Meeting (PFF/YM), \$150 for the School of the Spirit, \$100 for Lesbian, Gay, Bisexual, Transgender and Queer Friends Concerns (FLGBTQC).

8. Ann Miller, Co-clerk, Finance Committee, presented the proposed budget for 2019-2020. (Appendix 3). Finance responded to a request from M&W and added a line item to purchase an Automatic External Defibrillator (AED). M&W plans to schedule training next fall in its use as well as CPR and First Aid training. Final approval of the budget will take place at the June MWAB. There is an AED provided by Carolina Friends School in the schoolhouse we may use if needed.

9. Jeff Brown, Clerk, Piedmont Friends Fellowship (PFF), presented a report on the PFF spring retreat, April 19-21, 2019 at Carolina Friends School. (Appendix 4). We celebrated the 50th Anniversary of Quaker House. Another celebration will take place at Quaker House September 21, 2019. We accepted this report with gratitude.

10. Emilie Condon, Meeting Representative to Piedmont Friends Yearly Meeting (PFYM), presented the annual report. A suggestion was made to list the member meetings in the report. The report was accepted with this addition and with gratitude. (Appendix 5).

11. Tom Ludlow, member, Care & Counsel and Finance Committees, presented the final minute for Claire Bates' War-impacted People's Dialogue Project. (Appendix 6). We will consult Claire about the possibility of putting a link to her manual on our web site and having her give a forum when she is in town. We approved the final minute for Claire Bates' War-impacted People's Dialogue Project.

12. Matt read a letter of introduction for Emilie Condon, Peter Malone, and family for their travel in June to Northern Ireland, including Quaker Cottage in Belfast where John Hite worked 1992-94. (Appendix 7). We approved the letter of introduction.

13. Friends Committee on North Carolina Legislation (FCNCL) requests appointees from Meetings to serve on its General Committee and to attend the first meeting on Saturday, June 22. Karen Porter volunteered to represent us. Anyone else interested should let Matt know. We approved Karen Porter to represent us.

14. Next MWAB will be 9 am Sunday June 16, 2019.

APPENDIX 1

Inter-Faith Council Committee Annual Report May 19, 2018

The Inter-Faith Council (IFC) was formed in 1963 when seven local women, including members of Chapel Hill Friends Meeting, united to coordinate volunteer efforts to address poverty in our community. Fifty-six years later, the IFC continues to work to provide nutritious food, dignified and affordable housing, and meaningful social connections for the most vulnerable families and individuals. The meeting's IFC committee works to keep the meeting apprised of IFC concerns, to publicize ways for Friends to contribute, and to remain informed of other congregations' work to support this legacy organization. Members of the committee are the following: James Bartow, Emilie Condon, Asta Crowe, Ann Drake, Max Drake, Gwyn Hein, Dottie Heninger and Carolyn Stuart (clerk).

Committee members volunteer regularly in IFC programs. Asta completes data entry in the administrative office. Asta, Carolyn, Dottie, Gwyn, Ann and Max cook on first Thursdays at the Community Kitchen. Carolyn attends IFC Liaison Committee meetings, in which she learns how other congregations support the work of IFC and shares the meeting's efforts in this regard.

Ongoing activities

Friends are asked to contribute food for the IFC Pantry and to support the IFC through financial contributions. Asta, Carolyn and Max check the food and financial contributions in the foyer weekly. Food is taken to the pantry and checks are delivered to the administrative office.

The meeting is responsible for cooking lunch on the first Thursday of each month. Friends enjoy this opportunity to create healthy meals from the kitchen's larder, to fellowship with each other, and to converse and eat with those we serve. Friends who regularly cook at the first Thursday lunches are Asta Crowe, Ann Drake, Max Drake, Dottie Heninger, Nancy Martin, Paul Munk, Bonnie Raphael, Carolyn Stuart and Carolyn White. We are grateful to Paul Munk who brings men from Orange Correctional Center. We invite others to join us from 9:00 until 12:30, or for any portion of that time.

In November and December of each year, the committee publicizes and encourages Friends to donate money for Holiday meals. This past year, the IFC contributed 824 Thanksgiving and Christmas meals to families in need. Friends were also encouraged to participate in RSVVP program on November 13, 2018, a program in which many local restaurants donate 10 percent of proceeds on that day to the IFC. Friends have been generous in both supporting Holiday meals and the RSVVP program.

We are grateful for the assistance the IFC offers returning citizens from Orange Correctional Center by providing shelter at the Community House (men's residential shelter). Approximately 30 men from OCC have been served by IFC over the past few years. Currently, five returning citizens from OCC live in the IFC Community House.

Special Events

Food First forum: Jackie Jenks, Executive Director of the IFC presented a forum on October 28, 2018 on the topic, "How can we help IFC feed vulnerable families in our community?" Jackie described progress on the Food First Project, a \$5.3 million campaign to construct a new building at 110 West Main Street, which has long housed the administrative offices, Food Pantry and Emergency Financial Services. Plans are to move into the new building in the spring or summer of 2020. At that time, the Community Kitchen, which for more than 30 years has operated at the Rosemary Street facility, will join the other programs in the new facility. The Community Kitchen will be expanded, enabling the program to serve 67 percent more clients. The Food Pantry will be enlarged, providing space for more fresh food. The new facility will be more welcoming for clients and provide improved space for client counseling for Emergency Financial Services and administrative space for the staff. Substantial progress has been made on reaching the capital campaign goal, but there remains a gap. Jackie looks forward to being able to house all IFC programs in one location.

Note: Currently all IFC programs are being provided at the Rosemary Street location. While this is a challenge for IFC staff and volunteers, we're grateful to the town of Chapel Hill for continuing to offer the facility. Better days are coming.

Crop Walk: The Crop walk, an annual fund raising event, raises money for international hunger relief (75 percent of money raised) and supports IFC efforts (25 percent) to feed those in need. Crop Walk was held on March 24, 2019 this year. The meeting raised \$1,305.00. Eight meeting walkers enjoyed the sunshine, exercise and opportunities to visit as we participated in the walk. The committee thanks Dave Curtin, who enrolled the meeting on the IFC website to facilitate online contributions.

Next year, we plan to publicize and encourage purchase of Mother's Day cards created by the children at Homestart, the women's shelter.

Our quarterly meetings are open. We welcome Friends to join us.

We paid special attention to members and attenders who do not currently serve on a committee. From this list and from the Meeting Directory we filled all the vacancies we could, matching names and talents with committee needs. We were unable to identify an additional member for Ministry and Worship and will continue to work with the committee to fill their needs.

Our Meeting committees vary in size greatly, with our Transitions and Support and Peace and Justice Committees as two of our larger. Both these outreach committees fulfill important roles in our Meeting. We would remind members and attenders, however, that tending to the functioning of our Meeting requires support for us to sustain the vibrant meeting we are. We hope that members and attenders will continue to recognize vacancies on meeting-sustaining committees as important opportunities to serve.

This year, the Archives committee was laid down. Members of Nominations have been in touch with committee clerks to suggest that the tasks of Archives be absorbed into other committees. Care and Council and the Library Committee are taking on many of these tasks.

Nominations appointed a search committee to identify a new clerk. Carolyn White convened this group comprised of Kitty Bergel, Tom Ludlow, Dave Curtin, and Ken Grogan. They met in worship and discerned the experience, and gifts required to be the clerk. They were thorough in their process and were pleased with the depth of leadership they identified among our members. They were even more pleased with the name they brought to Nominations. A name we recommend to MFWAB today.

Nominations met several times and communicated regularly by email. Our membership included Gwynne Pomeroy (co-clerk), Dottie Heninger (co-clerk), Carolyn White, Leslie Rountree, Chris Stanley, Michael Jokinen, Annette Broadwell, and Matt Drake (Clerk of Meeting). We were grateful for the division of labors we adopted to facilitate our work.. Gwynne (working off a form created by Kyle) maintained our records, a daunting task. The final report of our committee is presented today for consideration, and for adoption by MWAB in June.

As you look at the report, note that the gray spaces represent new committee members and names in bold face are members who are renewing their committee commitments. The names brought forward reflect our best attempt to be accurate. Any corrections will be made before June MWAB. Just let committee members know of needed changes.

PFF Report to Chapel Hill Friends Meeting

Piedmont Friends Fellowship (PFF) held its 51st annual meeting and weekend retreat April 19-21, 2019 at Carolina Friends School in Durham. A subset of the member meetings of PFF are members of the Piedmont Friends Yearly Meeting, including Chapel Hill Friends Meeting. The Yearly Meeting held its business meetings in the same location on April 20, intertwined with PFF.

The Saturday morning program was led by Kindra Bradley, Executive Director of Quaker House. The stories told by former directors Chuck Fager and Lynn and Steve Newsome, and by counselors, in person and in videos, were moving and inspiring. Friends realized that "we are Quaker House" in a memorable discussion of the history and value of the services delivered in Fayetteville.

Fellowship time was informal this year, and Friends took advantage of Tom Munk's games, songs accompanied by Claire Bates and others, and impromptu discussions.

On Easter Sunday, PFF held its annual business meeting, which was well attended by Chapel Hill Friends. PFF was grateful that CHFM shifted its Meeting for Worship with Attention to Business to a Thursday evening to avoid a third First Day conflict with PFF.

Piedmont Friends Yearly Meeting Representatives Annual Report Fifth Month 2019

The fourth annual session of Piedmont Friends Yearly Meeting (PFYM) met at Carolina Friends School April 19-21, 2019. The gathering brought together Friends from the nine member monthly meetings and worship groups which include Abingdon in Virginia, Chapel Hill, Charlotte, Eno Friends of Hillsborough, Fancy Gap in Virginia, New Garden, Salem Creek, Upstate in South Carolina, and Raleigh. Visitors were welcomed from Quaker House, Friends Committee on National Legislation, Friends General Conference, Quaker Earthcare Witness, Quaker Voluntary Service Baltimore Yearly Meeting Stony Run Meeting, Five Rivers Meeting in Conway, SC and Palmetto Friends in SC. The retreat registration totaled 83 adults.

Presiding Clerk, Gary Hornsby, read his message and review of Interim Meeting activity 2018-2019. Kathy Metzo of Charlotte Meeting presented the statistics report. The report of the spiritual condition of member meetings was also shared. An epistle committee was appointed consisting of Marian Beane, Alice Carlton, and Carol Cothern. This summary of the annual meeting will be approved at the June Interim Meeting and shared widely with Friends in the wider Quaker world. Bill Moore reported on the PFF/YM new web site in the Quaker Cloud. Jointly with Piedmont Friends Fellowship, we heard reports from Quaker organizations such as Quaker House, American Friends Service Committee, Friends Committee on National Legislation, Quaker Earthcare Witness, and Friends General Conference.

One of the most meaningful parts of our time together was the sharing out of the silence our responses to the query: *What has been most on the hearts of your meeting this year.* We also remembered those who have passed from out midst during this year.

During annual sessions, we came to unity around the proposal to establish a Friends Committee on North Carolina Legislation (FCNCL) under the spiritual care of PFYM. We enthusiastically supported the founding of FCNCL and committed ourselves to ongoing support of its mission: "to strengthen our service and witness in the broader world by advocating for North Carolina state law and policies that are just, compassionate, and respectful of the inherent worth of every person and the Earth upon which we live." Each meeting will be asked to appoint up to three representatives to FCNCL.

Nominating Committee made its report. We approved the appointment of Sally Freeman and Paul Kleever as rising Assisting Clerks and Alice Carlton as Recording Clerk. Gary Hornsby will serve another year as Clerk. We expressed our appreciation to those transitioning from service and those beginning.

PFYM relies on Piedmont Friends Fellowship (PFF) for programming and financial support for the Yearly Meeting. This year we celebrated the 50th Anniversary of the founding of Quaker House in which Chapel Hill Meeting played a large role as did Piedmont Friends Fellowship. In addition, we had the opportunity to hear about the 150 years of faithful Quaker witness of Ramallah Friends School in Palestine when Arthur Meyer Boyd and Margaret (Meg)Boyd Meyer of Stony Run Friends Meeting in Baltimore Yearly Meeting spoke about their recent six month sojourn at the School and their impressions of everyday life in Palestine which continues to be challenging under occupation.

Chapel Hill Representatives attend four PFYM Interim Meetings in June, August (jointly with PFF Reps), November, and February to take care of business and plan the PFYM Annual Meeting.

We value the fellowship we enjoyed this weekend and opportunities to strengthen and deepen our connections with each other. Serving as meeting representatives to PFYM is a fulfilling role, and we urge others in Chapel Hill Meeting to consider this in the future. We ended again with a group photo.

<u>Final Minute for War-Impacted People's Dialogue Project Development</u> <u>Chapel Hill Friends Meeting - Meeting for Worship With Attention to Business</u> <u>May 19, 2019</u>

Many people in the U.S. experience impacts of war: from refugees and military members and their families to concerned community members, peace activists, and anyone who suffers a loss of societal resources due to military spending. From April 2018 to April 2019, Claire Bates received support to focus time on development of an approach meant to connect those impacted by war in any way in dialogue groups to learn from each other's experience and work together for peace. Claire received \$4500 in financial support from the Clarence and Lilly Pickett Endowment for Quaker Leadership (CLPEQL), administration of these funds through Chapel Hill Friends Meeting (CHFM), and spiritual oversight and support through a committee of Friends composed primarily of CHFM members.

Claire learned a lot - both concrete lessons related to her project (the War-Impacted People's Dialogue Project), and spiritual lessons, too.

For the War-Impacted People's Dialogue Project, Claire met with mentors, attended conferences, read relevant books, organized and facilitated pilot groups, built community networks, and conducted over 30 interviews toward the development of this method. The result is a 75-page dialogue resource manual she will be sharing with interested communities who may carry on this work as they are led starting in early May 2019. Claire hopes iterative discussions with communities who put this method to work will allow the manual to evolve over time.

Especially due to moving to be near to project mentors, and due to health, financial, and family challenges, Claire experienced the project period as a time of challenge, even of wandering. She learned many spiritual lessons such as:

- the importance of relying on community
- the process of sensing her own leading
- the way a project plays out differently across different communities and geographic areas
- deeper trust that she will be led and her needs will be met
- the fresh wind of a new leading into activism through song.

Claire thanks CLPEQL, CHFM, and her support committee (Liz Bates, Alice Carlton, David Curtin, Jan Hutton, Tom Ludlow, and Curt Torell) whose compassion and insight she says have seen her through.
